BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 448H-3, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§448H-3 Elevator mechanics licensing board; appointment;
- 4 organization. There is created an elevator mechanics licensing
- 5 board within the department of commerce and consumer affairs for
- 6 administrative purposes. The board shall consist of seven
- 7 members: [four] five shall be licensed elevator mechanics[τ] and
- 8 two shall be public members not connected or associated with the
- 9 elevator or building industry[, and one shall be the director of
- 10 labor and industrial relations or the director's designee who is
- 11 an employee of the department of labor and industrial relations
- 12 and has expertise in elevator and escalator installation and
- 13 maintenance]."
- 14 SECTION 2. Statutory material to be repealed is bracketed
- 15 and stricken. New statutory material is underscored.
- 16 SECTION 3. This Act shall take effect upon its approval.
