- 5 nondisclosure agreements; prohibited. (a) No employer shall
- 6 enter into or require an employee to enter into [, as a condition
- 7 of employment, a nondisclosure agreement that prevents the
- 8 employee from disclosing or discussing sexual harassment or
- 9 sexual assault occurring in the workplace, at work-related
- 10 events, between employees, or between an employer and an
- 11 employee."

- 13 and stricken. New statutory material is underscored.
