

A BILL FOR AN ACT

RELATING TO AN ALTERNATE ROUTE SITE SELECTION SURVEY IN PUNA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Puna is one of the
- 2 fastest growing areas in the State. It's anticipated that by
- 3 2035, the Puna district will grow by approximately forty-two
- 4 thousand eighty residents, nearly double the current population
- in the district and representative of nearly forty per cent of 5
- 6 the total population change by 2035. In comparison, the
- 7 populations in the North and South Hilo districts are expected
- 8 to increase by ten per cent or less by 2035.
- 9 The legislature further finds that the Kau and Puna
- 10 districts have the highest percentage of the population
- 11 considered low-income and living below the poverty line. This
- 12 subset of the population typically relies on transit and
- 13 nonmotorized modes of transportation more than any other income
- 14 levels.
- 15 Hilo is the primary employment center in the region, with
- 16 over forty per cent of jobs located within this area. As a
- 17 result, average traffic volumes near Hilo on Keeau-Pahoa Road



- 1 (Highway 130) peak at approximately twenty thousand two hundred
- 2 vehicles per day in each direction. Highway 130 provides the
- 3 sole access between Hawaii Belt Road and communities on the
- 4 eastern tip of the island, such as Puna, Pahoa, and Kalapana.
- 5 Trips from Hilo to the southernmost portion of Puna would take
- 6 up to two hours as estimated by the travel demand forecasting
- 7 model.
- 8 The legislature finds that Highway 130 is the primary
- 9 arterial and only access route into the southeastern portion of
- 10 the Puna area. The legislature further finds that because of
- 11 this limited road access, the residents of Puna experience
- 12 severe traffic congestion, which impact the quality of life of
- 13 the Puna residents and may also result in fatal delays of
- 14 emergency services.
- 15 The purpose of this Act is to require the department of
- 16 transportation, in collaboration with the county of Hawaii, to
- 17 conduct site surveys on the island of Hawaii to identify the
- 18 most suitable location for an alternate route in Puna below
- **19** Highway 130.
- 20 SECTION 2. (a) The department of transportation, in
- 21 collaboration with the county of Hawaii, shall conduct site



- 1 surveys on the island of Hawaii to identify the most suitable
- 2 location for an alternate route in Puna below Highway 130.
- 3 (b) Any lands on the island of Hawaii owned by the State
- 4 or county of Hawaii may be considered in determining where to
- 5 conduct site surveys. Lands owned by private parties may be
- 6 considered and site surveys may be conducted pursuant to
- 7 agreements with landowners.
- 8 (c) The department of transportation, in collaboration
- 9 with the county of Hawaii, shall submit a report of its findings
- 10 and recommendations to the legislature no later than twenty days
- 11 prior to the convening of the regular session of 2023. The
- 12 report shall include:
- 13 (1) A list of lands determined to be the most suitable
- 14 location for an alternate route in Puna below Highway
- 130, including information regarding ownership of each
- parcel of land;
- 17 (2) A discussion of any accessibility issues regarding the
- 18 lands;
- 19 (3) Any proposed legislation; and
- 20 (4) Any other matters that the department and county
- believe are relevant for consideration.



1	SECTION	3.	There	is	appropriated	out	of	the	general

- 2 revenues of the State of Hawaii the sum of \$ or so
- 3 much thereof as may be necessary for fiscal year 2022-2023 for
- 4 the purposes of this Act.
- 5 The sum appropriated shall be expended by the department of
- 6 transportation for the purposes of this Act.
- 7 SECTION 4. This Act shall take effect on July 1, 2022.
