

### A BILL FOR AN ACT

RELATING TO TRAFFIC FINES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to enable the
- 2 respective counties to impose and collect fines for violations
- 3 of the statewide traffic code, in addition to the fines imposed
- 4 by the State under Chapter 291C, Hawaii Revised Statutes.
- 5 SECTION 2. Section 291C-111, Hawaii Revised Statutes, is
- 6 amended by amending subsection (a) to read as follows:
- 7 "(a) With respect to highways under their respective
- 8 jurisdictions, the director of transportation is authorized to
- 9 and the counties by ordinance may prohibit or restrict the
- 10 stopping, standing, or parking of vehicles where the stopping,
- 11 standing, or parking is dangerous to those using the highway or
- 12 where the stopping, standing, or parking of vehicles would
- 13 interfere unduly with the free movement of traffic; provided
- 14 that the violation of any law or any ordinance, regardless of
- 15 whether established under this or any other section, prohibiting
- 16 or restricting the stopping, standing, or parking of vehicles
- 17 shall constitute a traffic infraction. [The] Except as provided

- 1 in section 291C-171, the counties shall not provide any other
- 2 penalty, civil or criminal, or any other charge, in the form of
- 3 rental or otherwise, in place of or in addition to the fine to
- 4 be imposed by the district court for any violation of any
- 5 ordinance prohibiting or restricting the stopping, standing, or
- 6 parking of vehicles.
- 7 This section shall not be construed as prohibiting the
- 8 authority of the director of transportation or the counties to
- 9 allow the stopping, standing, or parking of motor vehicles at a
- 10 "T-shaped" intersection on highways under their respective
- 11 jurisdictions; provided that such stopping, standing, or parking
- 12 of motor vehicles is not dangerous to those using the highway or
- 13 where the stopping, standing, or parking of motor vehicles would
- 14 not unduly interfere with the free movement of traffic.
- 15 The appropriate police department and county or prosecuting
- 16 attorney of the various counties shall enforce any law or
- 17 ordinance prohibiting or restricting the stopping, standing, or
- 18 parking of vehicles, including but not limited to the issuance
- 19 of parking tickets. Any person committing a violation of any
- 20 law or ordinance, regardless of whether established under this
- 21 or any other section, prohibiting or restricting the stopping,

- 1 standing, or parking of vehicles shall be subject to a fine to
- 2 be enforced and collected by the district courts of this State
- 3 and to be deposited into the state general fund for state use."
- 4 SECTION 3. Section 291C-171, Hawaii Revised Statutes, is
- 5 amended to read as follows:
- 6 "\$291C-171 Disposition of fines and forfeitures. (a) All
- 7 fines and forfeitures collected upon conviction or upon the
- 8 forfeiture of bail of any person charged with a violation of any
- 9 section or provision of the state traffic laws and all
- 10 assessments collected relating to the commission of traffic
- 11 infractions shall be paid to the director of finance of the
- 12 State[-]; provided that each county by ordinance may impose
- 13 additional fines for the violation of any section or provision
- 14 of the state traffic laws. Within thirty days after the
- 15 effective date of the county ordinance, the applicable traffic
- 16 violations bureau shall prepare citation forms for the police
- 17 department of that county showing all state and county fines.
- 18 Persons receiving citations having county fines may contest the
- 19 county fines in the same manner that state fines are contested.
- 20 The respective traffic violations bureaus shall collect the
- 21 fines for the counties and shall remit the fines to the

- 1 respective directors of budget and fiscal services, or finance,
- 2 of the counties on a semi-annual basis.
- 3 (b) In addition to any monetary assessment imposed for a
- 4 traffic infraction, the court may impose penalties on all
- 5 outstanding traffic citations and judgments. The penalties
- 6 shall be established pursuant to rules approved by the supreme
- 7 court; provided that the amounts of the penalties shall be based
- 8 upon a graduated scale that increases in proportion to the
- 9 length of the delinquency. Any interest penalty imposed as
- 10 provided in this section may be waived by the court for good
- 11 cause. All penalties collected for such outstanding citations
- 12 and judgments shall be paid to the director of finance of the
- 13 State[-]; provided that, if the county has enacted an ordinance
- 14 imposing an additional fine for the infraction, the director
- 15 shall remit the counties' share, if any, of the penalty to the
- 16 respective directors of budget and fiscal services, or finance,
- 17 of the counties on a semi-annual basis."
- 18 SECTION 4. Statutory material to be repealed is bracketed
- 19 and stricken. New statutory material is underscored.
