A BILL FOR AN ACT

RELATING TO JUNETEENTH DAY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to establish June 19 2 of each year as a state holiday, in recognition of the history 3 and legacy of slavery in the United States and in honor of the 4 significant roles, contributions, and achievements of African 5 Americans in the history of the United States and Hawaii and the 6 fundamental importance of equal treatment for all, regardless of 7 race, color, or national origin. 8 SECTION 2. Section 8-1, Hawaii Revised Statutes, is 9 amended to read as follows: 10 "§8-1 Holidays designated. The following days of each 11 year are set apart and established as state holidays: 12 The first day in January, New Year's Day; 13 The third Monday in January, Dr. Martin Luther King, Jr., 14 Day; The third Monday in February, Presidents' Day; 15 16 The twenty-sixth day in March, Prince Jonah Kuhio
