A BILL FOR AN ACT

RELATING TO THE REDUCED IGNITION PROPENSITY CIGARETTE PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the reduced ignition
- 2 propensity cigarette law took effect on September 30, 2009. As
- 3 stated in section 132C-1, Hawaii Revised Statutes, the intent of
- 4 this law is "to require that only reduced ignition propensity
- 5 cigarettes be sold in the State." Certifications for cigarettes
- 6 must be renewed every three years at a fee of \$375 per cigarette
- 7 brand/style, which must be paid to the state fire council.
- 8 These fees are deposited into the reduced ignition propensity
- 9 cigarette special fund. Moneys in the special fund are used to
- 10 pay for an administrator, random testing, and other
- 11 administrative and enforcement costs.
- In 1979, the legislature abolished the state fire marshal's
- 13 office and created the state fire council, which comprises the
- 14 four county fire chiefs and is administratively attached to the
- 15 department of labor and industrial relations. The goal of the
- 16 state fire council is to develop and maintain a comprehensive
- 17 fire service emergency management network for the protection of

- 1 life, property, and the environment throughout the State. The
- 2 state fire council is tasked with reviewing and adopting the
- 3 state fire code, providing administrative oversight of the
- 4 reduced ignition propensity cigarette program, providing
- 5 assistance with the application and administration of federal
- 6 grants for the fire service, assisting and coordinating with the
- 7 statewide delivery of fire training programs, coordinating the
- 8 collection of fire data, and supporting contingency planning
- 9 needs for firefighters. The council may establish statewide
- 10 qualifications for testing, certifying, and credentialing
- 11 individuals who perform maintenance and testing of portable fire
- 12 extinguishers, fire protection systems, and fire alarm systems.
- 13 The council may also advise the governor and the legislature on
- 14 matters related to fire prevention, fire protection, and life
- 15 safety. The state fire council is a voting member of the state
- 16 building code council, whose responsibilities are delineated in
- 17 section 107-24, Hawaii Revised Statutes.
- 18 From its inception until 2001, the state fire council had
- 19 no funding for staff to fulfill its responsibilities. The
- 20 council relied upon county personnel to perform its duties along
- 21 with their normal functions within their fire departments. In

- 1 2001, the governor directed the department of labor and
- 2 industrial relations to allocate \$35,000 in its budget to fund
- 3 the first part-time employee. In 2011, an additional \$71,000
- 4 was appropriated by the legislature to hire two additional
- 5 personnel. With money from the reduced ignition propensity
- 6 cigarette special fund, the state fire council would be able to
- 7 fund statewide educational and training efforts for the
- 8 protection of life, property, and the environment, such as the
- 9 statewide firefighter's safety guide program for Hawaii's youth
- 10 and the residential smoke alarm installation program for
- 11 Hawaii's at-risk senior population. The state fire council
- 12 could also hire additional personnel to oversee the coordination
- 13 of statewide fire data collection and analysis and administer
- 14 federal fire-related grants.
- 15 Accordingly, the purpose of this Act is to authorize the
- 16 use of the reduced ignition propensity cigarette program special
- 17 fund to support the duties and responsibilities of the state
- 18 fire council in addition to administering and enforcing the
- 19 reduced ignition propensity cigarette program.
- 20 SECTION 2. Section 132C-9, Hawaii Revised Statutes, is
- 21 amended to read as follows:

12	requirements of section 132C-4, including employing one full-									
13	time administrator and one full-time assistant whose duties									
14	include:									
15	(1)	Adopting administrative rules for program								
16		implementation, establishing compliance inspections,								
17		and approving forms and enforcement procedures and								
18		guidelines;								
19	(2)	Receiving certifications for approximately six hundred								
20		different brands and styles of cigarettes from the								
21		manufacturers;								

1	(3)	Compiling a list of the digarette brands and styles							
2		for which manufacturers have submitted certifications							
3		verifying tax stamp compliance with the department of							
4		the attorney general, and posting the list of							
5		certified brands and styles on a state website for							
6		informational purposes only;							
7	(4)	Reviewing and approving, as needed, any alternative							
8		test methods or fire standard compliance markings							
9		submitted by the manufacturer; and							
10	(5)	If needed, submitting certified cigarettes to an							
11		accredited laboratory for testing to verify that							
12		performance standards have been met.							
13	<u>(c)</u>	Moneys in the special fund may also be administered							
14	and expen	ded by the state fire council to defray the cost of							
15	statewide	fire prevention, education, life safety, and							
16	preparedness programs, especially as they relate to youth,								
17	seniors,	and persons with disabilities, including the hiring of							
18	administr	ative personnel."
