### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 304A, Hawaii Revised Statutes, is
2	amended by adding a new section to part IV, subpart N, to be
3	appropriately designated and to read as follows:
4	"§304A- Research partnership program. (a) There is
5	established within the Hawaii natural energy institute a
6	research partnership program.
7	(b) The program shall allow a business or private entity
8	to partner with the institute or utilize the institute's
9	research to expand the business or private entity; provided that
10	the business or private entity:
11	(1) Hires local residents for at least sixty per cent of
12	all new jobs that have been created as a result of the
13	program; and
14	(2) Establishes its headquarters in the State.
15	(c) The institute shall adopt rules in accordance with
16	chapter 91 for the purposes of this section."
