The director shall adopt rules to regulate 6 tour aircraft operations by permit, which shall include but not 7 8 be limited to: 9 Identification of the types of aircraft to be (1)utilized; 10 The number of operations daily for each type of 11 (2) aircraft used and the days and hours of operation; 12 (3) Verification that the applicant is in compliance with 13 all state statutes, including but not limited to this 14 section; 15 (4) Verification that the applicant has the Federal 16 Aviation Administration certificate 121 or 135; 17
