A BILL FOR AN ACT

RELATING TO HIGHWAYS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hana highway, the 2 main access road between Haiku and Hana, is the primary artery 3 utilized by residents and a popular destination for visitors to 4 east Maui. As a primary transportation artery for east Maui, 5 and due to the age of Hana highway and its many bridges, it has 6 become increasingly unsafe to traverse at many locations. These 7 unsafe conditions have manifested in delays in the delivery of 8 life saving services, extended commutes for residents, and 9 accidents, as well as disputes between residents and visitors. 10 In addition, the Maui police department is unable to properly 11 manage the number of vehicles and people accessing Hana highway. 12 The legislature further finds that Haleakala highway, the 13 only access to Haleakala, is thirty-seven miles long and is 14 comprised of one lane running in either direction with no guardrails, little or soft shoulders along steep cliff sides, 15 16 and frequent switchbacks. Due to the elevation, Haleakala

- 1 experiences sudden and severe weather changes, which severely 2 impact visibility on the roadway. 3 The legislature believes that to ensure the safety of 4 residents and visitors of Maui, there needs to be weight limitations for certain vehicles and a sustainable funding 5 6 source to maintain and improve Maui's highways. 7 Accordingly, the purpose of this Act is to: 8 (1)Set weight limitations for tour operators and rental 9 vehicles; 10 (2) Establish user fees for certain vehicles to access 11 Hana highway and Haleakala highway; and 12 (3) Amend the highway development special fund to allow 13 the deposit of funds received from the user fees into 14 the special fund and authorize the funds to be used 15 for the development and improvement of Hana highway 16 and Haleakala highway. 17 SECTION 2. Chapter 264, Hawaii Revised Statutes, is 18 amended by adding two new sections to part I to be appropriately 19 designated and to read as follows: 20 "\$264-A Hana highway; Haleakala highway; tour vehicles;

12	VIII of chapter 46 and this part to pay for state
13	highway improvements;
14	(2) Interest from investment of deposits; [and]
15	(3) Moneys received pursuant to section 264-B; and

17	(b) Moneys in the highway development special fund shall
18	be used for the following purposes:
19	(1) Capital costs of qualifying proposed state highway
20	improvements; provided that funds received pursuant to
