

### A BILL FOR AN ACT

RELATING TO THE DIVISION OF BOATING AND OCEAN RECREATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 200, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part I to be appropriately
- 3 designated and to read as follows:
- 4 "<u>§200-</u> Fee schedules; parking fees. (a)
- 5 Notwithstanding any law to the contrary, the board may adopt,
- 6 amend, or repeal administrative fee schedules, exempt from
- 7 chapter 91, for all parking fees for locations under the
- 8 management of or operated by the division of boating and ocean
- 9 recreation. Administrative fee schedules may be adopted at
- 10 regular or special meetings of the board pursuant to section
- **11** 171-5.
- 12 (b) The division of boating and ocean recreation shall
- 13 post notice on the division's and department's websites of any
- 14 proposed amendments to administrative fee schedules at least
- 15 forty-five days prior to the meeting of the board at which the
- 16 amended administrative fee schedule is to be considered. The
- 17 notice shall include:

13	<u>171-5.</u>						
14	(d)	Any administrative fee schedule adopted, amended, or					
15	repealed	pursuant to this section shall become effective ten					
16	days afte	r adoption by the board, unless otherwise specified by					
17	the board	. If the board specifies a later effective date, the					
18	later dat	e shall be the effective date; provided that no					
19	administr	ative fee schedule shall have an effective date more					
20	than thir	ty days after adoption of the administrative fee					
21	schedule	by the board.

#### Report Title:

Board of Land and Natural Resources; Division of Boating and Ocean Recreation; Fee Schedules; Parking Fees
