
A BILL FOR AN ACT

RELATING TO THE DIVISION OF BOATING AND OCEAN RECREATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 200, Hawaii Revised Statutes, is
2 amended by adding a new section to part I to be appropriately
3 designated and to read as follows:

4 "\$200- Fee schedules; parking fees. (a)
5 Notwithstanding any law to the contrary, the board may adopt,
6 amend, or repeal administrative fee schedules, exempt from
7 chapter 91, for all parking fees for locations under the
8 management of or operated by the division of boating and ocean
9 recreation. Administrative fee schedules may be adopted at
10 regular or special meetings of the board pursuant to section
11 171-5.

12 (b) The division of boating and ocean recreation shall
13 post notice on the division's and department's websites of any
14 proposed amendments to administrative fee schedules at least
15 forty-five days prior to the meeting of the board at which the
16 amended administrative fee schedule is to be considered. The
17 notice shall include:



1 (1) The full text of the proposed amended administrative
2 fee schedule in Ramseyer format; and

3 (2) The date, time, and place where the board meeting is
4 to be held and where interested persons may provide
5 written testimony or be heard on the proposed
6 administrative fee schedule adoption, amendment, or
7 repeal.

8 (c) The board shall afford all interested persons an
9 opportunity to submit data, views, or arguments, orally or in
10 writing. The board shall fully consider all written and oral
11 submissions respecting the proposed administrative fee schedule
12 and shall make its decision at the meeting pursuant to section
13 171-5.

14 (d) Any administrative fee schedule adopted, amended, or
15 repealed pursuant to this section shall become effective ten
16 days after adoption by the board, unless otherwise specified by
17 the board. If the board specifies a later effective date, the
18 later date shall be the effective date; provided that no
19 administrative fee schedule shall have an effective date more
20 than thirty days after adoption of the administrative fee
21 schedule by the board.



1 (e) The division of boating and ocean recreation shall
2 maintain a file of administrative fee schedules in Ramseyer
3 format on the division's and department's websites.

4 (f) For the purposes of this section, "administrative fee
5 schedule" includes a fee range with a minimum and maximum amount
6 to be charged."

7 SECTION 2. New statutory material is underscored.

8 SECTION 3. This Act shall take effect on July 1, 2050.
