## A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that there is no
- 2 coordinated, statewide information system that tracks data
- 3 related to homelessness. The two largest sources of information
- 4 on homelessness are Partners In Care on Oahu and Bridging the
- 5 Gap for the islands of Hawaii, Maui, and Kauai. These two
- 6 programs are part of Hawaii's continuum of care, which
- 7 administers federal funding and oversees the coordinated entry
- 8 system for homeless resources, such as permanent supportive
- 9 housing, rapid rehousing, and transitional housing, in the
- 10 State. Various state agencies, including the department of
- 11 health, department of human services, department of public
- 12 safety, and the judiciary, as well as county agencies, also
- 13 maintain data relating to homelessness. Data relating to
- 14 homelessness that is shared between governmental agencies and
- 15 other organizations is currently done on a case-by-case basis to
- 16 accomplish specific tasks.

1 The legislature further finds that the homelessness data 2 collected within the State is siloed and subject to the rules 3 that govern the collecting entity. The legislature believes 4 that a statewide, shared homelessness information system can be 5 used to determine the availability of services at any point-intime to identify appropriate services, shelter, or housing 7 available to assist persons experiencing homelessness or at-risk 8 individuals; identify and report on gaps where homelessness services, shelter, or housing are required, but not available; 9 10 and inform policymakers on where funding may be appropriated to 11 address those gaps. The legislature also finds that a 12 coordinated, statewide homelessness data system would provide 13 helpful information to the Hawaii interagency council on 14 homelessness, which was established to advise on homelessness 15 issues within Hawaii. 16 Accordingly, the purpose of this Act is to establish a 17 statewide homelessness shelter and housing data clearinghouse to 18 be administered by the governor's coordinator on homelessness. 19 SECTION 2. Chapter 346, Hawaii Revised Statutes, is

amended by adding a new section to part XVIII to be

appropriately designated and to read as follows:

1	"§346- Statewide homelessness shelter and housing data
2	clearinghouse; annual report. (a) There is established within
3	the department of human services for administrative purposes a
4	statewide homelessness shelter and housing data clearinghouse.
5	The statewide shelter and housing data clearinghouse shall pull
6	existing client-level data from existing databases, including
7	but not be limited to information on persons experiencing
8	homelessness and available services, shelters, and housing
9	within the State.
10	(b) The governor's coordinator on homelessness shall, with
11	assistance from the Hawaii interagency council on homelessness,
12	maintain the statewide homelessness shelter and housing data
13	clearinghouse. The governor's coordinator on homelessness may
14	consult with other departments or agencies regarding data
15	security and client consent associated with in the maintenance
16	of the statewide homelessness shelter and housing data
17	clearinghouse.
18	(c) The governor's coordinator on homelessness shall
19	submit an annual report to the legislature on the homelessness
20	data collected within the State, including any proposed

1	legislatio	on, no later than twenty days prior to the convening of
2	each regu	lar session. The report shall also include:
3	(1)	Performance metrics relating to reducing the numbers
4		on homelessness;
5	(2)	Performance metrics relating to housing and services
6		inventory gaps, including but not limited to the
7		number of persons experiencing homelessness served and
8		placed into permanent housing and the cost per person
9		served;
10	(3)	Performance metrics to evaluate the State's
11		performance on homeless services, housing, care
12		coordination, and other needed services to end
13		homelessness; and
14	(4)	A long-term operational plan, including any funding
15		requirements necessary for the continued operation of
16		the statewide homelessness shelter and housing data
17		clearinghouse."
18	SECT	ION 3. There is appropriated out of the general
19	revenues	of the State of Hawaii the sum of \$300,000 or so much
20	thereof a	s may be necessary for fiscal year 2022-2023 for the

- 1 establishment of a statewide homelessness shelter and housing
- 2 data clearinghouse.
- 3 The sum appropriated shall be expended by the department of
- 4 human services for the purposes of this Act.
- 5 SECTION 4. New statutory material is underscored.
- 6 SECTION 5. This Act shall take effect on July 1, 2060.
