

### A BILL FOR AN ACT

RELATING TO PURCHASES OF HEALTH AND HUMAN SERVICES UNDER CHAPTER 103F, HAWAII REVISED STATUTES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 103F, Hawaii Revised Statutes, is
- 2 amended by adding two new sections to be appropriately
- 3 designated and to read as follows:
- 4 "\$103F- Payor of last resort. (a) Except as otherwise
- 5 provided by law, state moneys expended for procurements of
- 6 health and human services pursuant to this chapter shall be the
- 7 funding source of last resort.
- **8** (b) Each provider shall attest that it has pursued all
- 9 alternative sources of funding available to the provider for
- 10 services rendered before expending state moneys.
- 11 (c) The department of health, department of human
- 12 services, or other purchasing agency, as applicable, shall
- 13 monitor contracts to ensure compliance with this section. If
- 14 the purchasing agency, department of health, or department of
- 15 human services determines that a contracted provider has spent
- 16 state moneys in violation of this section, the provider shall

1 forfeit and repay those moneys to the purchasing agency. The 2 expending agency, attorney general, or other agency may take 3 action to recover the expended moneys. 4 §103F- Medicaid provider preference; awarding of 5 contracts. (a) A purchasing agency soliciting proposals for a 6 competitive purchase of services contract pursuant to 7 section 103F-402 shall give a preference to an applicant that is a qualified medicaid provider in the State. 8 9 (b) If two competing applicants that submit proposals for 10 the same purchase of services contract pursuant to 11 section 103F-402 are otherwise equivalent, the purchasing agency 12 shall select the applicant who is a qualified medicaid provider. 13 (c) An applicant that is not a qualified medicaid provider 14 at the time the contract is awarded shall have up to one year 15 after the date on the notice of award to apply and be qualified 16 as a medicaid provider by the department of human services. **17** (d) When applicable, the department of health shall make available to each provider being awarded a contract an 18 19 explanation, through a memorandum of understanding, of how the 20 provider may capture federal medicaid moneys."

1	SECTION 2. Section 103F-402, Hawaii Revised Statutes, is
2	amended by amending subsection (b) to read as follows:
3	"(b) The request shall state all criteria which will be
4	used to evaluate proposals, including the preferences pursuant
5	to section 103F- , and the relative importance of the proposal
6	evaluation criteria."
7	SECTION 3. This Act does not affect rights and duties that
8	matured, penalties that were incurred, and proceedings that were
9	begun before its effective date.
10	SECTION 4. New statutory material is underscored.
11	SECTION 5. This Act shall take effect upon its approval.

#### Report Title:

Procurement; Health and Human Services; Department of Human Services; DOH; General Funds; Last Resort; Qualified Medicaid Provider; Preference

### Description:

Requires state moneys used to procure health and human services to be the funding source of last resort. Requires a purchasing agent to give a preference to an applicant that is a qualified medicaid provider when evaluating competitive purchase of health and human services contract proposals. Specifies that if 2 otherwise equally qualified applicants are seeking the same purchases of services contract, the purchasing agency shall select the applicant who is a qualified medicaid provider. Requires the Department of Health to provide an explanation of how providers may capture federal medicaid moneys.
