# A BILL FOR AN ACT

RELATING TO ACUPUNCTURE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that the regulation of  
2 medical professionals is important to ensure public safety and  
3 promote access to quality care. Acupuncture is one of the  
4 fastest growing fields in American health care due to expanded  
5 benefits under health insurance policies and medicare and is a  
6 popular treatment among patients seeking an alternative to  
7 prescription opioids and those with other medical conditions.  
8 The legislature further finds that a number of state laws  
9 regarding acupuncturists have not been updated in over twenty  
10 years, despite the growing demand for acupuncturists, changes to  
11 standards for national certifications, and expanded accredited  
12 educational programs, which now include master's and doctoral  
13 level degrees.

14           Accordingly, the purpose of this Act is to make  
15 comprehensive updates to chapter 436E, Hawaii Revised Statutes,  
16 regarding acupuncture practitioners to reflect modernized scopes  
17 of practice and licensing requirements.



1 SECTION 2. Chapter 436E, Hawaii Revised Statutes, is  
2 amended by adding three new sections to be appropriately  
3 designated and to read as follows:

4 **"§436E-A Requirements for initial licensure.** (a) To  
5 qualify for licensure after July 1, 2023, an applicant shall  
6 submit evidence satisfactory to the board that the applicant  
7 meets the following educational and examination requirements:

8 (1) An individual applying for initial licensure shall  
9 have successfully completed an acupuncture medicine  
10 program from an accredited acupuncture medicine  
11 institution; provided that those applicants who  
12 graduated with an earned master's degree may apply to  
13 the board for the "L.Ac." license designation, and  
14 those applicants who graduated with an earned  
15 doctorate degree may apply to the board for the  
16 "D.Ac." license designation; and

17 (2) All applicants for initial licensure shall pass  
18 examinations and be certified by the National  
19 Certification Commission for Acupuncture and Oriental  
20 Medicine, or its successor entity.



1        (b) Applicants who have earned a bachelor's, master's, or  
2 doctoral degree from a foreign university or college shall  
3 demonstrate curricula and standards equivalent to or higher than  
4 accredited institutions in the United States, which have been  
5 recognized and approved by the board. The board may contract  
6 with a third-party agency to determine equivalency, at cost to  
7 the applicant.

8        **§436E-B Legacy exemptions.** Any current acupuncture  
9 licensees in the State as of July 1, 2023, shall be designated  
10 legacy status by the board for their current license  
11 designation, allowing for the practice of acupuncture medicine.  
12 If a license that was issued before July 1, 2023, lapses and is  
13 not restored within two years of its expiration date, the  
14 licensee shall be subject to the licensure requirements pursuant  
15 to section 436E-A.

16        **§436E-C Reciprocity.** (a) The board may issue a license  
17 by reciprocity to an acupuncturist if the applicant:

18        (1) Files an application and pays fees as prescribed by  
19        the board;

20        (2) Holds a current, unencumbered, active license in  
21        another state or territory that requires



1 qualifications equivalent to or greater than the  
2 qualifications for licensure in the State as specified  
3 in section 436E-A; and

4 (3) Holds a current certification with the National  
5 Certification Commission for Acupuncture and Oriental  
6 Medicine, or its successor entity.

7 (b) For applicants who graduated before September 1, 2000,  
8 the board may issue a license by reciprocity to an acupuncturist  
9 if the applicant:

10 (1) Files an application and pays fees as prescribed by  
11 the board;

12 (2) Holds a current, unencumbered, active license in  
13 another state or territory; and

14 (3) Holds a current certification with the National  
15 Certification Commission for Acupuncture and Oriental  
16 Medicine, or its successor entity."

17 SECTION 3. Section 436E-1, Hawaii Revised Statutes, is  
18 amended to read as follows:

19 "[+]§436E-1[+] **Declaration of necessity for regulation and**  
20 **control.** The legislature hereby finds and declares that  
21 acupuncture medicine is an evidence-based medicine rooted in



1 traditional and modern modalities and that the practice of  
 2 acupuncture [is a theory and method for] medicine includes  
 3 examination, evaluation, diagnosis, and treatment of [illness  
 4 and disability and for strengthening and invigorating the body  
 5 and as such affects] the patient, therefore requiring regulation  
 6 and control for public health, safety, and welfare[, and  
 7 therefore there is a necessity that individuals practicing  
 8 acupuncture be subject to regulation and control]."

9 SECTION 4. Section 436E-2, Hawaii Revised Statutes, is  
 10 amended as follows:

11 1. By adding seven new definitions to be appropriately  
 12 inserted and to read:

13 "Accredited acupuncture medicine institution" means a  
 14 school or college accredited or recognized as a candidate for  
 15 accreditation by an acupuncture medicine accrediting body  
 16 recognized by the United States Department of Education.

17 "Acupuncture medicine" means the evidence-based medicine  
 18 rooted in traditional theories and practices, integrated with  
 19 modern biomedical theories and practices.



1       "Acupuncture medicine doctor" means an acupuncture  
2 practitioner engaged in the practice of advanced acupuncture  
3 medicine.

4       "Licensed acupuncturist" means an acupuncture practitioner  
5 who has complied with all educational and professional  
6 examination requirements as determined by the board and whose  
7 license remains in good standing with the board, utilizing the  
8 license designation "L.Ac.".

9       "Licensed doctor of acupuncture" means an acupuncture  
10 medicine doctor who has complied with all educational and  
11 professional examination requirements as determined by the board  
12 and whose license remains in good standing with the board,  
13 utilizing the license designation "D.Ac.".

14       "Practice of acupuncture medicine" means the practice of  
15 acupuncture with adjunctive therapies, including but not limited  
16 to manual, mechanical, electrical, light, sound,  
17 electromagnetic, thermal therapy, herbal and nutraceutical  
18 medicines, lifestyle and nutritional counseling, movement, and  
19 other traditional and modern techniques as further determined by  
20 rules adopted by the board.



1       "Practice of advanced acupuncture medicine" means the  
2 practice of acupuncture medicine and the use of advanced  
3 diagnostics, specialties, and therapeutics, as further  
4 determined by rules adopted by the board."

5       2. By amending the definition of "acupuncture  
6 practitioner" to read:

7       ""Acupuncture practitioner" means a person engaged in the  
8 practice of acupuncture[-] medicine."

9       3. By amending the definition of "practice of acupuncture"  
10 to read:

11       ""Practice of acupuncture" means [~~stimulation of a certain~~  
12 ~~acupuncture point or points on the human body for the purpose of~~  
13 ~~controlling and regulating the flow and balance of energy in the~~  
14 ~~body. The practice includes the techniques of piercing] the  
15 integrative examination, evaluation, diagnosis, prevention, and  
16 treatment of a physical, mental, or emotional disease in the  
17 patient by stimulating tissue by puncturing the skin [by  
18 ~~inserting needles and point stimulation by the use of~~  
19 ~~acupressure, electrical, mechanical, thermal, or traditional~~  
20 ~~therapeutic means.] with a needle approved by the United States~~~~



1 Food and Drug Administration to various depths or utilizing  
2 other means to achieve a response."

3 SECTION 5. Section 436E-3, Hawaii Revised Statutes, is  
4 amended to read as follows:

5 "~~§436E-3 [License required.]~~ Licensure. Except as  
6 otherwise provided by law, no person shall engage in the  
7 practice of acupuncture, practice of acupuncture medicine, or  
8 practice of advanced acupuncture medicine or use the title  
9 "acupuncturist" in [this] the State, either gratuitously or for  
10 pay, [~~or shall offer to so practice, or shall announce~~  
11 ~~themselves either publicly or privately as prepared or qualified~~  
12 ~~to so practice any method of acupuncture]~~ without having [a  
13 ~~valid unrevoked license or]~~ an acupuncture medicine intern  
14 permit [from the State; provided that the requirement for a  
15 permit shall not be enforced until the board has initially  
16 adopted rules] pursuant to section 436E-3.6[-] or an "L.Ac." or  
17 "D.Ac." license designation from the board."

18 SECTION 6. Section 436E-3.5, Hawaii Revised Statutes, is  
19 amended to read as follows:

20 "~~§436E-3.5 Physicians and osteopaths not exempt.~~ Persons  
21 licensed under chapter 453 who desire to engage in the practice



1 of acupuncture, practice of acupuncture medicine, or practice of  
2 advanced acupuncture medicine shall be subject to licensing  
3 under this chapter."

4 SECTION 7. Section 436E-3.6, Hawaii Revised Statutes, is  
5 amended to read as follows:

6 "[+]§436E-3.6[+] **Acupuncture medicine intern permit**  
7 **required.** [~~(a) Except as otherwise provided by law, no~~] No  
8 person shall engage in the practice [~~as an~~] of acupuncture,  
9 practice of acupuncture medicine, or practice of advanced  
10 acupuncture medicine as an intern in [~~this~~] the State, either  
11 gratuitously or for pay, [~~without having first obtained a permit~~  
12 ~~from the board. This permit shall entitle the applicant to~~  
13 ~~engage in the practice of acupuncture for a period of four years~~  
14 ~~under the immediate supervision of a licensed acupuncturist duly~~  
15 ~~licensed under this chapter.~~

16 ~~(b) An acupuncture intern permit may be reissued once, for~~  
17 ~~a period not to exceed one year, upon written request to the~~  
18 ~~board and payment of the required fee.~~

19 ~~(c) The board shall adopt rules pursuant to chapter 91~~  
20 ~~defining the functions of an acupuncture intern, establishing~~  
21 ~~the requirements to be met by an applicant for an acupuncture~~



1 ~~intern permit, and specifying the procedures for the immediate~~  
2 ~~supervision of the acupuncture intern by a licensed~~  
3 ~~acupuncturist.] unless the intern:~~

4       (1) Is actively enrolled in a program with an accredited  
5           acupuncture medicine institution;

6       (2) Has obtained a permit from the board, which shall be  
7           valid for four years and may be renewed once for a  
8           period not to exceed one year; and

9       (3) Is practicing under the immediate supervision of an  
10           acupuncture practitioner or acupuncture medicine  
11           doctor who is licensed in the State and contracted or  
12           employed through an accredited acupuncture medicine  
13           institution."

14       SECTION 8. Section 436E-6, Hawaii Revised Statutes, is  
15 amended to read as follows:

16       "**§436E-6 Board of acupuncture.** (a) There shall be a  
17 board of acupuncture, the members of which shall be appointed by  
18 the governor.

19       The board shall consist of five persons, two of whom shall  
20 be private citizens and three shall be [~~acupuncturists licensed~~

1 ~~in accordance with this chapter.]~~ licensed acupuncturists or  
2 licensed doctors of acupuncture.

3 (b) [~~Commencing July 1, 1992, and thereafter, each]~~ Each  
4 person appointed to the board shall have a four-year term and  
5 shall serve [~~not~~] no more than two consecutive terms. [~~Members~~  
6 ~~appointed to the board prior to July 1, 1992, shall be permitted~~  
7 ~~to continue to serve on the board until such time when a maximum~~  
8 ~~of eight consecutive years from the date of initial appointment~~  
9 ~~has been attained.]"~~

10 SECTION 9. Section 436E-7, Hawaii Revised Statutes, is  
11 amended to read as follows:

12 "**§436E-7 Powers and duties of the board.** In addition to  
13 any other powers and duties authorized by law, the board shall:

14 (1) Adopt rules in accordance with chapter 91 to carry out  
15 the purposes of this chapter, with special emphasis on  
16 the health and safety of the public;

17 (2) [~~Develop~~] Define and clarify ongoing standards for  
18 licensure;

19 (3) Define and clarify standards and practices for license  
20 renewal, including continuing education requirements;



- 1        [~~3~~] (4) Prepare, administer, and grade examinations,  
2                provided that the board may contract with a testing  
3                agency to provide those services;
- 4        [~~4~~] (5) Issue, renew, suspend, and revoke licenses;
- 5        [~~5~~] (6) Register applicants or holders of a license;
- 6        [~~6~~] (7) Investigate and conduct hearings regarding any  
7                violation of this chapter and any rules of the board;
- 8        [~~7~~] (8) Maintain a record of its proceedings; [~~and~~]
- 9        (9) Define and clarify reciprocity for persons licensed in  
10                other jurisdictions visiting the State for purposes of  
11                education and instruction, within a limited scope of  
12                time;
- 13        (10) Define and clarify standards for reciprocity for  
14                persons licensed in other jurisdictions who have:
- 15                (A) Completed their education prior to the year 2000;  
16                (B) Maintained their license; and  
17                (C) Maintained their certification with the National  
18                Certification Commission for Acupuncture and  
19                Oriental Medicine; and



1       ~~[(8)]~~ (11) Do all things necessary to carry out the  
2                   functions, powers, and duties set forth in the  
3                   chapter."

4           SECTION 10. Section 436E-9, Hawaii Revised Statutes, is  
5 amended to read as follows:

6           "~~[+]§436E-9[+]~~ **Biennial renewal**~~[-]~~; continuing education.

7   (a) Every person holding a license under this chapter shall  
8 register with the board and pay a biennial fee on or before  
9 June 30 of each odd-numbered year. Failure to pay the biennial  
10 fee shall constitute a forfeiture of the license as of the date  
11 of expiration. Any license so forfeited may be restored within  
12 ~~[one year]~~ two years after the expiration upon filing of an  
13 application and payment of a restoration fee.

14       (b) Beginning with the renewal for the licensing biennium  
15 commencing July 1, 2025, and every biennial renewal thereafter,  
16 all licensees in the State shall be in compliance with  
17 continuing education requirements, as approved by the board, by  
18 obtaining at least thirty credit hours, which shall include at  
19 least two credit hours of ethics and at least two credit hours  
20 of safety. The board shall adopt rules pursuant to chapter 91  
21 relating to the requirements and standards that continuing



1 education programs shall meet to obtain recognition and approval  
2 from the board.

3 (c) To determine compliance with the continuing education  
4 requirement under subsection (b), the board may conduct a random  
5 audit of licensees. A licensee selected for audit shall be  
6 notified by the board. Within sixty days of notification, the  
7 licensee shall provide the board documentation to verify  
8 compliance with the continuing education requirements.

9 (d) Licensees shall hold a current and valid  
10 cardiopulmonary resuscitation certification."

11 SECTION 11. Section 436E-10, Hawaii Revised Statutes, is  
12 amended to read as follows:

13 **"§436E-10 Revocation or suspension of licenses[-];**  
14 **penalties.** (a) In addition to any other actions authorized by  
15 law, any license to engage in the practice of acupuncture,  
16 practice of acupuncture medicine, or practice of advanced  
17 acupuncture medicine under this chapter may be revoked or  
18 suspended by the board of acupuncture at any time in a  
19 proceeding before the board for any cause authorized by law,  
20 including but not limited to the following:



- 1 (1) Obtaining a fee on the assurance that a manifestly  
2 incurable ailment can be permanently cured;
- 3 (2) The use of false, fraudulent, or deceptive advertising  
4 and making untruthful and improbable statements;
- 5 (3) [~~Habitually using~~] Using any [~~habit-forming~~]  
6 intoxicant or controlled substance [~~, such as opium or~~  
7 ~~any of its derivatives, morphine, heroin, or cocaine;~~]  
8 that impairs or compromises a licensee's duties, as  
9 determined by rules;
- 10 (4) Procuring a license through fraud, misrepresentation,  
11 or deceit;
- 12 (5) Professional misconduct [~~or~~], gross carelessness,  
13 ethics violations, or manifest incapacity [~~in the~~  
14 ~~practice of acupuncture;~~], as determined by rules; or
- 15 (6) Violating any rules adopted under this chapter.
- 16 (b) Any person except a person licensed under this chapter  
17 who practices, treats, or instructs in any phase of acupuncture  
18 or acupuncture medicine without a license or permit issued by  
19 the board, or uses any word or title to induce the belief that  
20 the person is engaged in the practice of any type of acupuncture  
21 or acupuncture medicine, shall be guilty of a misdemeanor and



1 subject to a fine of no less than \$1,000 for each day of  
2 violation. The department may also seek all legal and equitable  
3 remedies available to it for the enforcement of the provisions  
4 of this chapter, including injunctive relief."

5 SECTION 12. Section 436E-4, Hawaii Revised Statutes, is  
6 repealed.

7 [~~"§436E-4 Exemptions. A licensed acupuncturist of another~~
