

### A BILL FOR AN ACT

RELATING TO SEXUAL HEALTH EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that existing sexual
- 2 education standards within secondary schools in the State are
- 3 not providing students with the knowledge and tools necessary to
- 4 make responsible, informed, and empowered choices about their
- 5 sexuality, gender, relationships, and sexual and reproductive
- 6 health.
- 7 The legislature further finds that the current emphasis on
- 8 abstinence and problem-focused language offered in Hawaii
- 9 schools can contribute to ongoing stigmatization of sexual
- 10 health topics. Comprehensive sex education that covers forms of
- 11 sexual expression, healthy sexual and non-sexual relationships,
- 12 diverse identities across gender and culture, sexual
- 13 orientation, and consent is vital to ensuring that students feel
- 14 safe and empowered to learn, ask questions, and make positive
- 15 choices for themselves. For the foregoing reasons, a broader,
- 16 more comprehensive sex education program should be provided to
- 17 secondary school students. Providing this type of comprehensive

13		sexual health topics to destigmatize and promote	
14		sexual health.	
15	SECT	ON 2. Chapter 302A, Hawaii Revised Statutes, is	
16	amended by adding a new section to be appropriately designated		
17	and to read as follows:

19	department	shall offer comprehensive training for teachers and	
20	educationa	al officers on sexual health topics that include	
21	positive a	and accurate representations of the lesbian, gay,

9	amended by	y amending subsection (a) to read as follows:
10	"(a)	Sexuality health education programs funded by the
11	State sha	ll [ <del>provide</del> ]:
12	(1)	Provide medically accurate and factual information
13		that is age appropriate and includes education on
14		abstinence, contraception, and methods of disease
15		prevention to prevent unintended pregnancy and
16		sexually transmitted disease, including human
17		<pre>immunodeficiency virus[-]; and</pre>
18	(2)	Include sexual health topics that include positive and
19		accurate representations of the lesbian, gay,
20		bisexual, transgender, queer or questioning, intersex,
21		asexual, and other sexual orientations and gender

Sexual Health; Training; Education

#### Description:

Requires DOE to provide comprehensive training for teachers and educational officers on sexual health topics that include positive and accurate representations of the lesbian, gay, bisexual, transgender, queer or questioning, intersex, asexual, and other sexual orientations and gender identities and persons of color communities, to destignatize and promote sexual health. Requires sexual health programs to include similar sexual health topics to destignatize and promote sexual health.
