## A BILL FOR AN ACT

RELATING TO SEXUAL HEALTH EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that existing sexual
- 2 education standards within secondary schools in the State are
- 3 not providing students with the knowledge and tools necessary to
- 4 make responsible, informed, and empowered choices about their
- 5 sexuality, gender, relationships, and sexual and reproductive
- 6 health.
- 7 The legislature further finds that the current emphasis on
- 8 abstinence and problem-focused language offered in Hawaii
- 9 schools can contribute to ongoing stigmatization of sexual
- 10 health topics. Comprehensive sex education that covers forms of
- 11 sexual expression, healthy sexual and non-sexual relationships,
- 12 diverse identities across gender and culture, sexual
- 13 orientation, and consent is vital to ensuring that students feel
- 14 safe and empowered to learn, ask questions, and make positive
- 15 choices for themselves. For the foregoing reasons, a broader,
- 16 more comprehensive sex education program should be provided to
- 17 secondary school students. Providing this type of comprehensive

3	Ther	efore, the purpose of this Act is to:
4	(1)	Require the department of education to provide

20	departmen	t shall offer comprehensive training for teachers and
21	education	al officers on sexual health topics that include

6	(b) The department may coordinate and contract with any
7	state or county department or agency or any other expert in the
8	field of sexual health education and response to implement this
9	section."
10	SECTION 3. Section 321-11.1, Hawaii Revised Statutes, is
11	amended by amending subsection (a) to read as follows:
12	"(a) Sexuality health education programs funded by the
13	State shall [ <del>provide</del> ]:
14	(1) Provide medically accurate and factual information
15	that is age appropriate and includes education on
16	abstinence, contraception, and methods of disease
17	prevention to prevent unintended pregnancy and
18	sexually transmitted disease, including human
19	immunodeficiency virus[+]; and
20	(2) Include sexual health topics that include positive and
21	accurate representations of the lesbian, gay,

1	bisexual, transgender, queer or questioning, intersex,
2	asexual, other sexual orientations and gender
3	identities, persons of color, and disability
4	communities to destigmatize and promote sexual
5	health."
6	SECTION 4. Statutory material to be repealed is bracketed
7	and stricken. New statutory material is underscored.
8	SECTION 5. This Act shall take effect on July 1, 2050.
