

#### A BILL FOR AN ACT

RELATING TO TWO-LINED SPITTLEBUGS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the two-lined
- 2 spittlebug, Prosapia bicincta, is an invasive insect that
- 3 attacks key forage grasses used by the livestock ranching
- industry. In 2016, the State's first two-lined spittlebug
- 5 infestation was discovered in Kailua-Kona, on the island of
- 6 Hawaii, where the pest had damaged nearly two thousand acres of
- 7 pasture land. Many high-quality pasture grasses, including
- 8 Bracharia, Kikuyu, Pangola, St. Augustine, and Bermuda, are
- 9 susceptible to attacks by the two-lined spittlebug. During
- 10 heavy infestations, dying plant tissue cascades from the leaves
- 11 to the roots, ultimately causing the death of the whole plant.
- 12 The resulting damage does not allow for any regrowth, requiring
- 13 ranchers to totally replant affected pastures.
- 14 The legislature further finds that two-lined spittlebug
- 15 infestations have reduced the quality of some forage pastures in
- Hawaii by decreasing their nutritional value, palatability, and 16
- 17 productivity. Infestations of the pest also promote the

- 1 establishment of weeds and lower-quality foraging grasses.
- 2 Monthly surveys carried out on the island of Hawaii since 2017
- 3 show that the pest is rapidly expanding its range and now covers
- 4 more than two hundred seventy-five square miles. The loss of
- 5 production in affected areas is estimated to be about \$133 per
- 6 acre, and it is forecast that severely impacted pasture will
- 7 cost \$500 per acre for up to ten years to recover.
- 8 The legislature recognizes that livestock ranching is a
- 9 highly productive and extremely valuable industry on all of
- 10 Hawaii's major islands. The State's livestock industry has an
- 11 estimated annual value of more than \$68,000,000, with over one
- 12 hundred forty-two thousand beef cattle on more than one thousand
- 13 three hundred ranches. Collectively, these ranches cover nearly
- 14 twenty-five per cent of the State's land area.
- 15 The legislature additionally finds that the department of
- 16 agriculture is beginning efforts to mitigate and control two-
- 17 lined spittlebug infestations using funds received by the State
- 18 from the Coronavirus State and Local Fiscal Recovery Funds.
- 19 Currently, the department is working on a direct contract to the
- 20 research corporation of the University of Hawaii to support
- 21 rancher activities in controlling two-lined spittlebugs in areas

- 1 devastated by the insect. However, more support and funding are
- 2 needed to continue the department's work in mitigating and
- 3 controlling the two-lined spittlebug population in Hawaii.
- 4 Accordingly, the purpose of this Act is to appropriate
- 5 funds to the department of agriculture to continue its efforts
- 6 to mitigate and control the two-lined spittlebug and for
- 7 recovery of the rangelands damaged by the invasive pest.
- **8** SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so
- 10 much thereof as may be necessary for fiscal year 2022-2023 for
- 11 mitigation and control of the two-lined spittlebug, including
- 12 reduction of the two-lined spittlebug population through the use
- 13 of insecticides, integration of weed management measures in
- 14 affected rangelands, and reseeding of pastures damaged by
- 15 infestations.
- 16 The sum appropriated shall be expended by the department of
- 17 agriculture for the purposes of this Act.
- 18 SECTION 3. The department of agriculture shall submit a
- 19 report of its findings and recommendations, including any
- 20 proposed legislation, to the legislature no later than twenty
- 21 days prior to the convening of the regular session of 2023

- 1 regarding efforts to mitigate and control the two-lined
- 2 spittlebug and for the recovery of pasture lands. The report
- 3 shall also document the expenditure of funds and the progress of
- 4 activities funded by this Act.
- 5 SECTION 4. This Act shall take effect on July 1, 22.
