A BILL FOR AN ACT

RELATING TO AQUACULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that diversification of			
2	the State's economy is necessary to lessen the economic			
3	dependence on tourism and to respond to the economic downturn			
4	exacerbated by the coronavirus disease 2019 pandemic.			
5	Supporting local aquacultural productions can help the State			
6	move towards greater food sustainability and expand a home-based			
7	workforce. The legislature further finds that seafood demand			
8	outpaces supply and world fishery resources are quickly			
9	depleting. There is significant growth potential for the			
10	aquaculture industry in the State and for aspiring entrepreneurs			
11	looking to establish themselves in this global emerging			
12	industry.			
13	Accordingly, the purpose of this Act is to:			
14	(1) Establish provisions relating to the department of			
15	agriculture's governing of the business of			
16	aquaculture;			

1	(2)	Grant exclusive property rights to persons who
2		lawfully obtain the cultured progeny of wild plants
3		and animals by brood stock acquisition;
4	(3)	Clarify that any person who takes aquaculture products
5		without lawful entitlement shall be subject to
6		prosecution for theft;
7	(4)	Authorize the department of agriculture to regulate
8		the transportation, purchase, possession, and sale of
9		specific aquaculture products as may be necessary to
10		protect indigenous species;
11	(5)	Establish prohibitions relating to the spawning,
12		incubating, or cultivation of transgenic fish species
13		or any exotic species of finfish;
14	(6)	Make exemptions for certain research activities; and
15	(7)	Require the department of agriculture to prepare
16		programmatic environmental impact reports.
17	SECT	ION 2. Chapter 141 Hawaii Revised Statutes, is amended
18	by adding	nine new sections to part IV to be appropriately
19	designate	d and to read as follows:
20	"§14:	1- Definitions. As used in this part:

- 1 "Aquaculture" means that form of agriculture devoted to the
- 2 propagation, cultivation, maintenance, and harvesting of aquatic
- 3 plants and animals in marine, brackish, and fresh water. The
- 4 term "aquaculture" does not include species of ornamental marine
- 5 or freshwater plants and animals not utilized for human
- 6 consumption or bait purposes that are maintained in closed
- 7 systems for personal, pet industry, or hobby purposes.
- 8 "Chairperson" means the chairperson of the board of
- 9 agriculture.
- 10 "Department" means the department of agriculture.
- 11 "Exotic species" means a fish that is not indigenous to
- 12 Hawaii waters and does not currently exist as a viable
- 13 population in a wild condition in the State.
- "Indigenous species" means any aquatic life, wildlife, or
- 15 land plant species growing or living naturally in Hawaii without
- 16 having been brought to Hawaii by humans.
- 17 "Person" means any natural person or any partnership,
- 18 corporation, limited liability company, trust, or other type of
- 19 association.
- 20 §141- Powers, duties, and activities of the department.
- 21 (a) The business of aquaculture shall be governed by this part

- 1 and shall be exempt from any other provisions relating to
- 2 commercial fishing, harvesting, processing, and marketing.
- 3 (b) Except as provided in this part, the business of
- 4 aquaculture processing, distribution, and marketing shall be
- 5 administered by the chairperson.
- 6 (c) The chairperson may enter into an agreement with the
- 7 chairperson of the board of land and natural resources for the
- 8 resolution of any conflict regarding jurisdiction that arises
- 9 under this part.
- 10 (d) Any costs incurred by the department in implementing
- 11 this part shall be recovered pursuant to this part.
- 12 §141- Brood stock acquisition; exclusive property
- 13 rights. The cultured progeny of wild plants and animals
- 14 lawfully obtained by brood stock acquisition are the exclusive
- 15 property of that person who cultured them or that person's
- 16 successor in interest.
- 17 **§141-** Theft. Any person who takes aquaculture products
- 18 without lawful entitlement shall be subject to prosecution for
- 19 theft.
- 20 §141- Protection of indigenous species. (a) When
- 21 necessary for the protection of indigenous species, the

- 1 department may regulate the transportation, purchase,
- 2 possession, and sale of specific aquaculture products as
- 3 provided for in this section.
- 4 (b) The department may determine that aquaculture products
- 5 shall be accompanied by a document containing any of the
- 6 following information:
- 7 (1) The name, address, and registration number of the
- 8 aquaculture producer;
- 9 (2) The species;
- 10 (3) The weight, volume, or count within the container;
- 11 (4) The date of the shipment; and
- 12 (5) The name and address of the intended receiver.
- 13 (c) The department may require that certain aquaculture
- 14 products shall be additionally identified as being aquaculture
- 15 produced.
- 16 §141- Prohibited activities. (a) In the waters of the
- 17 Pacific Ocean that are regulated by the State, it shall be
- 18 unlawful to spawn, incubate, or cultivate any transgenic fish
- 19 species, or any exotic species of finfish. This section shall
- 20 not apply to species that are propagated and cultured for either
- 21 of the following:

- (1) Research conducted by, or on behalf of, the
 department; or
- (2) Release into the ocean waters for the purpose of
 recovery, restoration, or enhancement of indigenous
 species.
- 6 (b) Nothing in this section authorizes artificial
 7 propagation, rearing, or stocking of transgenic freshwater and
 8 marine fishes, invertebrates, crustaceans, or mollusks.
- 9 §141- Research activities. (a) Medical or scientific 10 research conducted on transgenic finfish species by accredited 11 academic institutions or private entities for research only and 12 not for commercial production may be authorized pursuant to a 13 permit issued by the department.
- (b) At a minimum, research activities conducted pursuant to this section shall be conducted in a closed system that has eliminated the risk of escape of transgenic finfish species and any potential disease they may transmit.
- (c) A permit application applied for pursuant to this
 section shall include a research plan specifying the objectives
 and goals of the proposed research.

- 1 (d) Nothing in this section shall be construed to require
- 2 the disclosure of proprietary information.
- 3 §141- Programmatic environmental reports. (a) The
- 4 department shall prepare programmatic environmental impact
- 5 reports for existing and potential commercial aquaculture
- 6 operations in both coastal and inland areas of the State if both
- 7 of the following conditions are met:
- 8 (1) Funds are appropriated to the department for this
- 9 purpose; and
- 10 (2) Matching funds are provided by the aquaculture
- industry.
- (b) For purposes of this section, "matching funds"
- 13 includes but is not limited to any funds expended by the
- 14 aquaculture industry before January 1, 2022, for the preparation
- 15 of a programmatic environmental impact report.
- 16 §141- Rulemaking authority. The department shall adopt
- 17 rules pursuant to chapter 91 to effectuate the purpose of this
- 18 part."
- 19 SECTION 3. Chapter 141, Hawaii Revised Statues, is amended
- 20 by designating sections 141-2.5 to 141-2.7 as part IV and
- 21 inserting a title before section 141-2.5 to read as follows:

1		"PART IV. AQUACULTURE"

Report Title:

Aquaculture; Department of Agriculture; Aquaculture Program

Description:

Establishes provisions relating to the Department of Agriculture's governing of the business of aquaculture. Grants exclusive property rights to persons who lawfully obtain the cultured progeny of wild plants and animals by brood stock acquisition. Clarifies that any person who takes aquaculture products without lawful entitlement shall be subject to prosecution for theft. Authorizes the Department of Agriculture to regulate the transportation, purchase, possession, and sale of specific aquaculture products as may be necessary to protect indigenous species. Establishes prohibitions relating to the spawning, incubating, or cultivation of transgenic fish species or any exotic species of finfish. Makes exemptions for certain research activities. Requires the Department of Agriculture to prepare programmatic environmental impact reports.
