### A BILL FOR AN ACT

RELATING TO THE BOARD OF AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that each island of the
- 2 State has different water resources and therefore unique
- 3 agricultural issues. The legislature further finds that the
- 4 complex needs of each island's agricultural community would be
- 5 better addressed by proper representation on the board of
- 6 agriculture.
- 7 Accordingly, the purpose of this Act is to amend the
- 8 composition of the board of agriculture by providing
- 9 representation from the islands of Molokai, Lanai, and Oahu.
- 10 SECTION 2. Section 26-16, Hawaii Revised Statutes, is
- 11 amended by amending subsection (a) to read as follows:
- "(a) The department of agriculture shall be headed by an
- 13 executive board to be known as the board of agriculture. The
- 14 board shall consist of [ten] thirteen members:
- 15 (1) One who shall be a resident of the [county] island of
- Hawaii;
