A BILL FOR AN ACT

RELATING TO THE BERNICE PAUAHI BISHOP MUSEUM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Bernice Pauahi
- 2 Bishop Museum is designated in state law as the State of Hawaii
- 3 Museum of Natural and Cultural History. The mission of the
- 4 museum is to inspire the community and visitors through the
- 5 exploration, celebration, and perpetuation of the extraordinary
- 6 history, culture, and environment of Hawaii and the Pacific.
- 7 Founded in 1889, Bishop Museum is now the largest museum in the
- 8 State and the premier natural and cultural history institution
- 9 in the Pacific, recognized throughout the world for its cultural
- 10 collections, research projects, consulting services, and public
- 11 educational programs. Bishop Museum also has one of the largest
- 12 natural history specimen collections in the world.
- 13 The purpose of this Act is to authorize the issuance of
- 14 general obligation bonds to assist Bishop Museum with a capital
- 15 improvement project.
- 16 SECTION 2. The director of finance is authorized to issue
- 17 general obligation bonds in the sum of \$10,000,000 or so much

- 1 thereof as may be necessary and the same sum or so much thereof
- 2 as may be necessary is appropriated for fiscal year 2022-2023
- 3 for the purpose of assisting the Bernice Pauahi Bishop Museum,
- 4 the State of Hawaii Museum of Natural and Cultural History, with
- 5 plans, design, construction, and equipment for repairing roofs
- 6 throughout the museum campus.
- 7 The sum appropriated shall be expended by the department of
- 8 accounting and general services for the purposes of this Act.
- 9 SECTION 3. The appropriation made for the capital
- 10 improvement project authorized by this Act shall not lapse at
- 11 the end of the fiscal biennium for which the appropriation is
- 12 made; provided that all moneys from the appropriation
- 13 unencumbered as of June 30, 2024, shall lapse as of that date.
- 14 SECTION 4. This Act shall take effect on July 1, 2044.
