

A BILL FOR AN ACT

RELATING TO STATE BOARDS AND COMMISSIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that all state board and

2 commission members are required to submit financial disclosures

3 to the state ethics commission. Act 230, Session Laws of Hawaii

4 2014, required the financial disclosure statements of certain

5 state board and commission members to be made public. As a

6 direct result, the state currently has many vacancies to fill

7 and the pool of qualified individuals that are willing to serve

8 on state boards and commissions has reduced and continues to

9 experience reductions.

10 The legislature further finds that community members who

11 are most qualified to serve are often not willing to pursue a

seat on state boards or commissions because of the requirement

13 that financial disclosures be made public. Those individuals

14 and their businesses often value privacy concerning

15 compensation. The State is at a critical stage across many

16 issues and it is imperative that it attract and retain strong

17 leaders to help it move forward. Removing the requirement that

- 1 financial disclosures be made public should increase the size
- 2 and quality of the pool of candidates for seats on state boards
- 3 and commissions, which would benefit the people of Hawaii.
- 4 The purpose of this Act is to require certain information
- 5 on the financial disclosure statements deemed to be public
- 6 records for non-paid volunteer members of state boards and
- 7 commissions to be redacted.
- 8 SECTION 2. Section 84-17, Hawaii Revised Statutes, is
- 9 amended by amending subsection (d) to read as follows:
- 10 "(d) The financial disclosure statements of the following
- 11 persons shall be public records and available for inspection and
- 12 duplication[+]; provided that all amounts reported pursuant to
- 13 subsection (f) by non-paid volunteer members of state boards,
- 14 commissions, and agencies listed under paragraph (8) shall be
- 15 redacted:
- 16 (1) The governor, the lieutenant governor, the members of
- the legislature, candidates for and delegates to the
- 18 constitutional convention, the trustees of the office
- of Hawaiian affairs, and candidates for state elective
