

### A BILL FOR AN ACT

RELATING TO SCHOOL FOOD PROGRAMS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that school food programs
- 2 play a critical role in improving the health of Hawaii's keiki
- 3 by encouraging consumption of fresh, locally grown foods. The
- 4 Hawaii farm-to-school program was established in 2015 to
- 5 transition the State's school food systems toward locally grown
- 6 food for the benefit of students, small businesses, local
- 7 farmers, and the environment. From 2016 through 2018, the 'Āina
- 8 Pono Executive Program oversaw two pilot projects in school
- 9 cafeterias on Oahu and Hawaii island to evaluate the feasibility
- 10 of and processes required to increase the amount of fresh, local
- 11 food on public school menus. The pilot projects were
- 12 overwhelmingly successful, highlighting the need to make similar
- 13 changes across the public school system.
- 14 The legislature further finds that implementing farm-to-
- 15 school programs statewide requires investment in school
- 16 cafeteria facilities and cafeteria staff training. The
- 17 department of education's one hundred ninety-three production

- 1 kitchens and forty-four serving kitchens require increased
- 2 investment to ensure proper maintenance and upgrades that will
- 3 facilitate scratch cooking in school food services. In 2020, a
- 4 kitchen assessment for all public schools on Kauai found that
- 5 the estimated needs in kitchen equipment totaled approximately
- 6 \$792,000 for eleven production sites. Given that Kauai school
- 7 kitchens are smaller than most in the State, these needs are
- 8 likely somewhat greater for the islands of Oahu, Maui, and
- 9 Hawaii.
- 10 Furthermore, training for cafeteria managers and staff is
- 11 required in the areas of scratch cooking, recipe development and
- 12 standardization, just-in-time food preparation, waste
- 13 management, and recordkeeping. The 'Āina Pono pilot projects at
- 14 the Kohala school complex and Mililani high school demonstrate
- 15 the importance of adequate training. With two months of
- 16 training, Kohala school complex kitchen staff went from serving
- 17 processed food to one hundred per cent scratch-cooked food. The
- 18 efforts of the cafeteria team led to fresh food purchases
- 19 increasing from a baseline of twenty-seven per cent to ninety-
- 20 two per cent. This increase coincided with more than \$30,000 in
- 21 savings and increased student participation in school food

- 1 programs. Similarly, the 'Aina Pono project at Mililani high
- 2 school resulted in a savings of \$106,658 over the course of one
- 3 semester while increasing local and fresh food purchases,
- 4 student participation, and staff morale.
- 5 The legislature finds that an investment in Hawaii's school
- 6 cafeteria facilities and staff training is an upfront investment
- 7 in the health of our keiki.
- 8 Accordingly, the purpose of this Act is to improve the
- 9 ability of school food programs to serve students fresh, locally
- 10 grown foods by appropriating funds for school cafeteria upgrades
- 11 and cafeteria staff training.
- 12 SECTION 2. The director of finance is authorized to issue
- 13 general obligation bonds in the sum of \$29,000,000 or so much
- 14 thereof as may be necessary and the same sum or so much thereof
- 15 as may be necessary is appropriated for fiscal year 2022-2023
- 16 for school cafeteria upgrades.
- 17 The sum appropriated shall be expended by the department of
- 18 education for the purposes of this Act.
- 19 SECTION 3. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$4,000,000 or so much

- 1 thereof as may be necessary for fiscal year 2022-2023 for
- 2 cafeteria staff training.
- 3 The sum appropriated shall be expended by the department of
- 4 education for the purposes of this Act.
- 5 SECTION 4. The appropriation made for the capital
- 6 improvement project authorized by this Act shall not lapse at
- 7 the end of the fiscal biennium for which the appropriation is
- 8 made; provided that all moneys from the appropriation
- 9 unencumbered as of June 30, 2024, shall lapse as of that date.
- 10 SECTION 5. This Act shall take effect on July 1, 2022.
