

### A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE TWENTY-SECOND REPRESENTATIVE DISTRICT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION	1.	The	director	of	finance	is	authorized	to	issue

- 2 general obligation bonds in the sum of \$5,670,000 or so much
- thereof as may be necessary and the same sum or so much thereof
- as may be necessary is appropriated for fiscal year 2022-2023
- 5 for the purpose of capital improvement projects for the twenty-

- 7 Jefferson elementary school
- 8 Design, construction, and equipment for
- a campus wide telecommunication
- 10 infrastructure upgrade.

- 12 Construction \$1,000,000
- \$20,000 13 Equipment

- 15 The sum appropriated for this capital improvement project
