
A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated from the sources of
3 funding indicated below to collective bargaining statewide (BUF
4 102) the following sums or so much thereof as may be necessary
5 to fund for fiscal year 2022-2023 all collective bargaining cost
6 items in the reopener agreement negotiated with the exclusive
7 representative of collective bargaining unit (6):

13 SECTION 2. Funds appropriated by this part shall be
14 allotted by the director of finance to the appropriate state

 3 102) the following sums or so much thereof as may be necessary

 5 cost adjustments authorized by chapter 89C, Hawaii Revised
 6 Statutes, for state officers and employees who are excluded from
 7 collective bargaining and belong to the same compensation plans
 8 as those officers and employees within bargaining unit (6):

4 that are not expended or encumbered by June 30, 2023, shall
5 lapse as of that date.

6 SECTION 7. This Act shall take effect on December 25,
7 2040.
