RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated from the sources of
3 funding indicated below to collective bargaining statewide (BUF
4 102) the following sums or so much thereof as may be necessary
5 to fund for fiscal biennium 2021-2023 all collective bargaining
6 cost items in the agreement negotiated with the exclusive
7 representative of collective bargaining unit (9):

1 shall be paid wholly or proportionately, as the case may be,
2 from the respective funds.

3 SECTION 14. The appropriations for fiscal year 2021-2022
4 shall not lapse at the end of that fiscal year; provided that
5 funds appropriated or authorized by this Act that are not
6 expended or encumbered by June 30, 2023, shall lapse as of that
7 date.

8 SECTION 15. This Act shall take effect on December 25,
9 2040.
