### A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF EDUCATION FOR A MAINTENANCE BASE YARD.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. This Act is recommended by the governor for immediate passage in accordance with section 9 of article VII of the Constitution of the State of Hawaii.

SECTION 2. On July 1, 2005, the department of education and the department of accounting and general services entered into a memorandum of understanding to supplement the transfer of

resources from the department of accounting and general services

- 9 Hawaii 2004. The memorandum of understanding included a
- 10 provision for the department of education to use facilities at
- 11 Shafter Flats to house its maintenance base yard. However, the

- 14 accounting and general services on June 4, 2021, to have the
- 15 department of education relocate from the Shafter Flats facility

- 11 thereof as may be necessary and the same sum or so much thereof
- 12 as may be necessary is appropriated for fiscal year 2021-2022
- 13 for the purpose of securing a maintenance base yard for the
- 14 department of education.
- 15 The sum appropriated shall be expended by the department of
- 16 education.
- 17 SECTION 4. The appropriation made for the capital
- 18 improvement project authorized by this Act shall not lapse at
- 19 the end of the fiscal biennium for which the appropriation is
- 20 made; provided that all moneys from the appropriation
- 21 unencumbered as of June 30, 2024, shall lapse as of that date.

JUSTIFICATION:

On July 1, 2005, the Department of Education and the Department of Accounting and General Services entered into a memorandum of understanding to supplement the transfer of resources from the Department of Accounting and General Services to the Department of Education per Act 51, Session Laws of Hawaii The memorandum of understanding included a provision for the Department of Education to use facilities at Shafter Flats to house its maintenance basevard. However, the economic downturn in 2020 and the limited amount of available resources resulted in a request made by the Department of Accounting and General Services on June 4, 2021, to have the Department of Education relocate from the Shafter Flats facility by October of 2021.

Since June of 2021, the Department of Education has been looking for a new facility to house its maintenance base yard. This facility is vital to be used for needed warehouse and storage space to allow the Department of Education to continue to service all of its facilities, including 257 public schools, 37 charter schools, and nearly 180,000 students statewide.

Impact on the public: Having a maintenance baseyard will allow the Department of Education to continue to service all of its facilities and maintain appropriate educational environments for students.

Impact on the department and other agencies:
The Department of Accounting and General
Services will be able to reduce expenses.
However, the Department of Education will
need funding for a new baseyard.
