### A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the stated mission
- 2 of the University of Hawaii at Manoa's athletic department is to
- 3 operate dynamic sports programs encouraging student-athletes in
- 4 their pursuit of excellence in the realms of academic
- 5 achievement and athletic competition at the highest levels.
- 6 While the athletic department has produced skilled talent and
- 7 provided quality sports entertainment for fans and the
- 8 community, there are concerns about the quality of the athletic
- 9 facilities and other inadequacies of the department. Therefore,
- 10 a management and financial audit would serve to improve the
- 11 athletic department and restore the public's confidence in its
- 12 ability to carry out its mission.
- 13 The purpose of this Act is to require and appropriate funds
- 14 for the office of the auditor to perform a management and
- 15 financial audit of the University of Hawaii at Manoa's athletic
- 16 department and submit a report of its findings and
- 17 recommendations to the legislature.

- 2 auditor to fulfill the legislature's request.
- 3 (d) The auditor shall submit a report of its findings and
- 4 recommendations, including any proposed legislation, to the
- 5 legislature no later than twenty days prior to the convening of
- 6 the regular session of 2023.
- 7 SECTION 3. There is appropriated out of the general
- 9 much thereof as may be necessary for fiscal year 2022-2023 for
- 10 the auditor to conduct a management and financial audit of the
- 11 University of Hawaii at Manoa's athletic department.
- 12 The sum appropriated shall be expended by the office of the
- 13 auditor for the purposes of this Act.
- 14 SECTION 4. This Act shall take effect on July 1, 2022.
