### A BILL FOR AN ACT

RELATING TO FEDERAL LANDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. (a) There is established within the department
2	of land and natural resources for administrative purposes a
3	Makua valley task force to prepare for the transfer of the
4	management of the Makua military reservation from the United
5	States Army when General Lease No. S-3848 expires.
6	(b) The Makua valley task force shall consist of the
7	chairperson of the board of land and natural resources, or the
8	chairperson's designee, and a member of the board of trustees of
9	the office of Hawaiian affairs, or a designee, who shall invite
10	the following persons to be members of the task force:
11	(1) A representative of the legislature;
12	(2) A representative of families who were evicted from the
13	Makua valley reserve or whose lands in the Makua
14	valley reserve were condemned by the federal
15	<pre>government;</pre>
16	(3) A representative of the aha moku advisory committee;

1	(4)	Three representatives, each representing a different
2		non-profit organization, having expertise on Makua
3		valley; and
4	(5)	A representative selected from a list provided by
5		Native Hawaiian organizations.
6	The	task force shall also invite the commanding officer of
7	the Unite	d States Army Pacific, or the commanding officer's
8	designee,	to serve as a military representative.
9	(c)	The members of the task force shall elect a
10	chairpers	on from among themselves.
11	(d)	In preparing for the transition of the management of
12	the Makua	military reservation away from the United States Army,
13	the task	force shall enter into discussions with the United
14	States Ar	my to:
15	(1)	Facilitate the expedient return of the Makua valley
16		reserve upon the expiration of the United States
17		Army's lease;
18	(2)	Ensure the clean-up of unexploded ordnance; and
19	(3)	Ensure the expansion of opportunities for cultural
20		access.

- 1 (e) The task force shall base its plans and policies on
- 2 the timely transfer of the lands currently held by the United
- 3 States Army under General Lease No. S-3848 to the State, which
- 4 shall:
- 5 (1) Hold the lands in trust as part of the public land
- 6 trust; and
- 7 (2) Transfer management and control of the lands to the
- 8 sovereign Native Hawaiian entity upon its recognition
- 9 by the United States and the State.
- 10 (f) The members of the task force shall serve without
- 11 compensation but shall be reimbursed for their actual and
- 12 necessary expenses, including travel expenses, incurred in
- 13 carrying out their official duties.
- 14 (g) The task force shall submit a report of its findings
- 15 and recommendations, including any proposed legislation, to the
- 16 legislature no later than twenty days prior to the convening of
- 17 the regular session of 2023.
- (h) The task force shall cease to exist six months after
- 19 the August 16, 2029, expiration of the United States Army's
- 20 lease for the Makua military reservation under General Lease No.
- 21 S-3848.



1	SECTION 2. (a) There is established within the department
2	of Hawaiian home lands for administrative purposes a Lualalei
3	valley task force to negotiate for the return of Lualualei naval
4	radio transmitting facility and the Lualualei naval ammunition
5	depot to the department of Hawaiian home lands.
6	(b) The Lualualei valley task force shall consist of the
7	chairperson of the Hawaiian homes commission, or the
8	chairperson's designee, and a member of the board of trustees of
9	the office of Hawaiian affairs, or a designee, who shall invite
10	the following persons to be members of the task force:
11	(1) A representative of the legislature;
12	(2) A representative of families who were evicted from the
13	Lualualei valley lands or whose lands in the Lualualei
14	valley were condemned by the federal government;
15	(3) A representative of the aha moku advisory committee;
16	(4) Three representatives, each representing a different
17	non-profit organization, having expertise on Lualualei
18	valley; and
19	(5) A representative selected from a list provided by
20	Native Hawaiian organizations.

1	The task force shall also invite the commanding officer of
2	the United States Navy Pacific Fleet, or the commanding
3	officer's designee, to serve as a military representative.
4	(c) The members of the task force shall elect a
5	chairperson from among themselves.
6	(d) The task force shall enter into negotiations with the
7	United States Navy to:
8	(1) Facilitate the expedient return of the Lualualei naval
9	radio transmitting facility and the Lualualei naval
10	ammunition depot to the State;
11	(2) Ensure the clean-up of unexploded ordnance; and
12	(3) Ensure the expansion of opportunities for cultural
13	access.
14	(e) The task force shall base its plans and policies on
15	the timely completion of negotiating the transfer of the lands
16	currently held by the United States Navy in Lualualei valley to
17	the State, which shall:
18	(1) Hold the lands in trust as part of the public land
19	trust; and

1	(2) Transfer management and control of the lands to the
2	sovereign Native Hawaiian entity upon its recognition
3	by the United States and the State.
4	(f) The members of the task force shall serve without
5	compensation but shall be reimbursed for their actual and
6	necessary expenses, including travel expenses, incurred in
7	carrying out their official duties.
8	(g) The task force shall submit a report of its findings
9	and recommendations, including any proposed legislation, to the
10	legislature no later than twenty days prior to the convening of
11	the regular session of 2023.
12	(h) The task force shall cease to exist six months after
13	the transfer of the Lualualei naval radio transmitting facility
14	and the Lualualei naval ammunition depot to the State.
15	SECTION 3. This Act shall take effect on July 1, 2022.
