

A BILL FOR AN ACT

RELATING TO THE STATE DRUG AND ALCOHOL TOXICOLOGY TESTING LABORATORY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 196, Session Laws of Hawaii 2021 (Act 196),
- 2 established the state drug and alcohol toxicology testing
- 3 laboratory special fund to support a state drug and alcohol
- 4 toxicology testing laboratory; specified that moneys in the
- 5 state highway fund may be expended for the cost of establishing
- 6 a state drug and alcohol toxicology testing laboratory; required
- 7 that fines imposed on offenders convicted of repeat or habitual
- 8 offenses involving operating a vehicle under the influence of an
- 9 intoxicant or convicted of operating a vehicle after a license
- 10 and privilege have been suspended or revoked for operating a
- 11 vehicle under the influence of an intoxicant be deposited into
- 12 the state drug and alcohol toxicology testing laboratory special
- 13 fund; and required the department of health to submit reports to
- 14 the legislature on expenditures from the state drug and alcohol
- 15 toxicology testing laboratory special fund.

	Act 190 also provided that the state drug and alcohor
2	toxicology testing laboratory special fund shall be abolished
3	and repealed on June 30, 2026, and any unencumbered remaining
4	balances shall lapse to the general fund. Act 196 did not
5	appropriate moneys from the state highway fund to be deposited
6	into the state drug and alcohol testing laboratory special fund
7	nor did Act 196 appropriate state drug and alcohol testing
8	laboratory special funds for the establishment of a state drug
9	and alcohol toxicology testing laboratory.
10	The purpose of this Act is to:
11	(1) Appropriate moneys from the state highway fund to the
12	department of health's state drug and alcohol
13	toxicology testing laboratory special fund for fiscal
14	year 2022-2023; and
15	(2) Authorize the department of health to expend funds
16	from the state drug and alcohol toxicology testing
17	laboratory special fund for the establishment of the
18	state drug and alcohol toxicology testing laboratory.
19	SECTION 2. There is appropriated out of the state highway
20	fund the sum of \$400,000 or so much thereof as may be necessary
21	for fiscal year 2022-2023 to be deposited into the state drug

- 3 SECTION 3. There is appropriated out of the state drug and
- 4 alcohol toxicology testing laboratory special fund the sum of
- 5 \$400,000 or so much thereof as may be necessary for fiscal year
- 6 2022-2023 for the establishment of a state drug and alcohol
- 7 toxicology testing laboratory, including the costs of laboratory
- 8 instrumentation, facility renovation and security upgrades,
- 9 office furniture and supplies, laboratory equipment, and other
- 10 purposes that support a state drug and alcohol toxicology
- 11 testing laboratory.
- 12 The sum appropriated shall be expended by the department of
- 13 health for the purposes of this Act.
- 14 SECTION 4. Any provision of this Act to the contrary
- 15 notwithstanding, the appropriation authorized under this Act
- 16 shall not lapse at the end of the fiscal year for which the
- 17 appropriation is made. Any unexpended and unencumbered balance
- 18 of the appropriations made in this Act as of the close of
- 19 business on June 30, 2023, shall lapse back to the credit of the
- 20 state highway fund.
- 21 SECTION 5. This Act shall take effect on July 1, 2022.
