### A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE STATE DRUG AND ALCOHOL TOXICOLOGY TESTING LABORATORY SPECIAL FUND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with article VII, section 9, of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. Act 196, Session Laws of Hawaii 2021 (Act 196),
- 5 established the state drug and alcohol toxicology testing
- 6 laboratory special fund to support a state drug and alcohol
- 7 toxicology testing laboratory; specified that moneys in the
- 8 state highway fund may be expended for the cost of establishing
- 9 a state drug and alcohol toxicology testing laboratory; required
- 10 that fines imposed on offenders convicted of repeat or habitual
- 11 offenses involving operating a vehicle under the influence of an
- 12 intoxicant or convicted of operating a vehicle after a license
- 13 and privilege have been suspended or revoked for operating a
- 14 vehicle under the influence of an intoxicant be deposited into
- 15 the state drug and alcohol toxicology testing laboratory special
- 16 fund; and required the department of health to submit reports to

- 1 the legislature on expenditures from the state drug and alcohol
- 2 toxicology testing laboratory special fund.
- 3 Act 196 also provided that the state drug and alcohol
- 4 toxicology testing laboratory special fund shall be abolished
- 5 and repealed on June 30, 2026, and any unencumbered remaining
- 6 balances shall lapse to the general fund. Act 196 did not
- 7 appropriate moneys from the state highway fund to be deposited
- 8 into the state drug and alcohol testing laboratory special fund,
- 9 nor did Act 196 appropriate state drug and alcohol testing
- 10 laboratory special funds for the establishment of a state drug
- 11 and alcohol toxicology testing laboratory.
- 12 The purpose of this Act is to:
- 13 (1) Appropriate moneys from the state highway fund to the
- department of health's state drug and alcohol
- 15 toxicology testing laboratory special fund for fiscal
- **16** vear 2021-2022; and
- 17 (2) Authorize the department of health to expend funds
- from the state drug and alcohol toxicology testing
- 19 laboratory special fund for the establishment of the
- state drug and alcohol toxicology testing laboratory.

- 1 SECTION 3. There is appropriated out of the state highway
- 2 fund the sum of \$2,000,000 or so much thereof as may be
- 3 necessary for fiscal year 2021-2022 to be deposited into the
- 4 state drug and alcohol toxicology testing laboratory special
- 5 fund established by Act 196, Session Laws of Hawaii 2021.
- 6 SECTION 4. There is appropriated out of the state drug and
- 7 alcohol toxicology testing laboratory special fund the sum of
- 8 \$2,000,000 or so much thereof as may be necessary for fiscal
- 9 year 2021-2022 for the establishment of a state drug and alcohol
- 10 toxicology testing laboratory, including the costs of laboratory
- 11 instrumentation, facility renovation and security upgrades,
- 12 office furniture and supplies, laboratory equipment, and other
- 13 purposes that support a state drug and alcohol toxicology
- 14 testing laboratory.
- 15 The sum appropriated shall be expended by the department of
- 16 health for the purposes of this Act.
- 17 SECTION 5. Any provision of this Act to the contrary
- 18 notwithstanding, the appropriation authorized under this Act
- 19 shall not lapse at the end of the fiscal year for which the
- 20 appropriation is made. Any unexpended and unencumbered balance
- 21 of the appropriations made in this part as of the close of



- 1 business on June 30, 2023, shall lapse back to the credit of the
- 2 state highway fund.
- 3 SECTION 6. This Act shall take effect upon its approval.
