A BILL FOR AN ACT

RELATING TO PESTICIDES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the public health
- 2 and welfare require more strict regulation of pesticides on
- 3 properties owned and controlled by the State. Particularly,
- 4 glyphosate; 2,4-D; chlorpyrifos; dicamba; and malathion are
- 5 dangerous carcinogenic pesticides, the use of which should be
- 6 strictly curtailed on state property, including at state parks,
- 7 recreational facilities, schools, roadways, correctional
- 8 institutions, office buildings, and other places owned or
- 9 controlled by the State.
- 10 The purpose of this Act is to prohibit the use of dangerous
- 11 pesticides on state lands and at state facilities.
- 12 SECTION 2. Chapter 149A, Hawaii Revised Statutes, is
- 13 amended by adding a new section to be appropriately designated
- 14 and to read as follows:
- 15 "\$149A- Dangerous pesticides; state lands. (a)
- 16 Dangerous pesticides shall be prohibited on any property owned
- or controlled by the State on or after July 1, 2022.

2	pesticides on private property or privately controlled land		
3	adjacent to a state road easement or on any other privately		
4	owned property;		
5	(c) Should an emergency arise that necessitates the		
6	temporary use of dangerous pesticides, the department		
7	administering a property on which the dangerous pesticides are		
8	to be used shall submit a formal request for exemption to the		
9	<pre>governor; provided that:</pre>		
10	(1) Actions taken under an exemption are solely for the		
11	purpose of mitigating the emergency;		
12	(2) All other methods available to mitigate the emergency		
13	have been demonstrated to be inadequate; and		
14	(3) The time frame for the exemption is established and		
15	presented by the department.		
16	Requests for emergency exemptions under this subsection shall be		
17	made by official communication from the applicable department to		
18	the governor.		
19	(d) Other pesticides not considered dangerous pesticides		
20	shall be used on state lands or by state entities pursuant to		
21	the following:

1	(1)	Pesticide use shall comply with section 149A-31;	
2	(2)	Any area on which the pesticide is applied shall be	
3		made inaccessible to the public until the product has	
4		dried or for an amount of time directed on the product	
5		label; provided that the area must be made	
6		inaccessible for no less than four hours after the	
7		pesticide was applied; and	
8	(3)	A visible notice in the form of a temporary sign shall	
9		be posted at the location of pesticide application	
10		identifying the pesticide used by name and listing	
11		known hazards and risks of the pesticide.	
12	<u>(e)</u>	As used in this section:	
13	<u>"Dan</u>	gerous pesticide" means Glyphosate; 2,4-D;	
14	Chlorpyri	fos; Dicamba; and Malathion-based pesticides.	
15	<u>"Eme</u>	rgency" means an urgent need to mitigate or eliminate a	
16	plant pes	t that threatens public health and safety.	
17	"Min	imum risk products and methods" are products and	
18	methods that are not regulated by the Environmental Protection		
19	Agency."		
20	SECT	ION 3. If any provision of this Act, or the	
21	applicati	on thereof to any person or circumstance, is held
