

A BILL FOR AN ACT

RELATING TO PROCUREMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that procurement			
2	activities throughout the State may not be consistently			
3	compliant with chapters 103D (the Hawaii Public Procurement			
4	Code) and 103F (relating to purchases of health and human			
5	services), Hawaii Revised Statutes, and the administrative rules			
6	adopted pursuant to those chapters. Many purchasers conduct			
7	procurement activities as part of their "other duties as			
8	assigned," and have minimal training and experience in public			
9	procurement. This can lead to mistakes resulting in increased			
10	costs to the government.			
11	Accordingly, the purpose of this Act is to:			
12	(1) Establish a working group to develop a plan for the			
13	phased consolidation of procurement services and staff			
14	within executive branch agencies within a five-year			
15	timespan, excluding the department of education,			
16	Hawaii health systems corporation, and university of			
17	Hawaii; and			

1	(2)	Appr	opriate moneys to the state procurement office to
2		supp	ort the activities of the working group.
3	SECT	ION 2	. (a) There is established a procurement
4	services	conso	lidation working group, which shall:
5	(1)	Deve	lop a plan for the phased consolidation of all
6		stat	e executive branch procurement services and staff
7		with	in five years, except the department of education,
8		Hawa	ii health systems corporation, and university of
9		Hawa	ii, under the state procurement office. The plan
10		shal	l include:
11		(A)	An identification of the specific positions and
12			functions to be transferred to the state
13			procurement office from each department;
14		(B)	Proposed dates of transfer for each position and
15			function;
16		(C)	Proposed procurement facility, personnel, and
17			operational infrastructure needs of the
18			consolidated procurement agency, with projections
19			on future integration needs as additional
20			agencies' procurement staff and services are
21			added;

1		(b) Recommendations to enable the state producement
2		office to provide expert support to the
3		procurement activities of all state agencies to
4		meet the needs of the agencies and the public;
5		and
6		(E) Recommendations to ensure that agency services
7		are not interrupted during the consolidation; and
8	(2)	Make recommendations to attract high quality
9		procurement professionals to the State, including the
10		use of internships and the feasibility of exempting
11		certain positions from the requirements of chapters 76
12		and 89, Hawaii Revised Statutes.
13	(b)	Members of the working group shall include:
14	(1)	The administrator of the state procurement office, who
15		shall serve as chairperson;
16	(2)	The head of each principal executive branch
17		department, except the department of education and
18		university of Hawaii, or that person's designee; and
19	(3)	Any other person that the administrator of the state
20		procurement office wishes to invite to serve on the
21		working group.

1	(0)	The working group shall be administratively accadined				
2	to the de	partment of accounting and general services. The state				
3	procurement office shall provide administrative support to the					
4	working group.					
5	(d)	No later than twenty days prior to the convening of				
6	the regular session of 2023, the working group shall submit to					
7	the legislature a report of its findings and recommendations,					
8	including:					
9	(1)	The plan for the phased consolidation of state				
10		procurement services developed pursuant to subsection				
11		(a)(1), including a detailed five-year phase-in				
12		schedule;				
13	(2)	Recommendations to attract high quality procurement				
14		professionals to the State; and				
15	(3)	Any proposed legislation.				
16	(e)	The working group shall dissolve on June 30, 2023.				
17	SECT	ION 3. There is appropriated out of the general				
18	revenues	of the State of Hawaii the sum of \$250,000 or so much				
19	thereof a	s may be necessary for fiscal year 2022-2023 for the				
20	state procurement office to support the activities of the					

procurement services consolidation working group, including the

hiring of staff and the creation of a phased consolidation plan.

The sum appropriated shall be expended by the state

procurement office for the purposes of this Act.

SECTION 4. This Act shall take effect on July 1, 2022.

Report Title:

Procurement; SPO; Phased Consolidation Plan; Working Group; Report; Appropriation

Description:

Establishes a procurement services consolidation working group, which shall develop a plan for the phased consolidation of all state executive branch procurement services and staff within five years, except those of the Department of Education, Hawaii Health Systems Corporation, and University of Hawaii, under the State Procurement Office. Requires the working group to recommend ways to attract high quality procurement professionals to the State. Appropriates moneys.
