BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 2 or so 3 much thereof as may be necessary for fiscal year 2021-2022 to protect the health, safety, and welfare of the people and 4 5 provide relief from disaster damages, losses, and suffering caused by extraordinary weather events that produced torrential 6 7 rains and resultant flooding in the county of , in , 20 . 8 9 The sum appropriated shall be allotted to the department of 10 defense and expended by the adjutant general solely for the 11 express stated purposes of this Act; provided that the funds 12 appropriated pursuant to this section shall not lapse at the end 13 of the fiscal year for which the funds have been appropriated; 14 provided further that any funds appropriated pursuant to this 15 section that are unencumbered as of June 30, , shall lapse 16 on that date; provided further that the funds appropriated

(a) Funds appropriated pursuant to this Act 2 shall be expended in accordance with section 127A-12(b), Hawaii 3 Revised Statutes, as the adjutant general and governor deem 4 appropriate. 5 (b) The appropriations and expenditures made pursuant to 6 this Act shall not be subject to the expenditure limitations 7 established in section 127A-16, Hawaii Revised Statutes. 8 SECTION 4. This Act shall take effect on July 1, 2050. 9
