## A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE III, SECTION 15, OF THE HAWAII STATE CONSTITUTION TO ENACT A SUPERMAJORITY VOTING REQUIREMENT FOR PASSAGE OF LEGISLATION PROPOSING TO RAISE OR CREATE TAXES AND LEGISLATION TO RAISE THE MINIMUM WAGE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to propose an
- 2 amendment to article III, section 15, of the Constitution of the
- 3 State of Hawaii to enact a two-thirds supermajority requirement
- 4 for passage of legislation proposing to raise taxes, create new
- 5 taxes and to raise the state minimum wage.
- 6 SECTION 2. Article III, section 15, of the Constitution of
- 7 the State of Hawaii is amended to read as follows:
- 8 "PASSAGE OF BILLS
- 9 Section 15. No bill shall become law unless it shall pass
- 10 three readings in each house on separate days. No bill shall
- 11 pass third or final reading in either house unless printed
- 12 copies of the bill in the form to be passed shall have been made
- 13 available to the members of that house for at least forty-eight
- 14 hours.

- 1 Every bill when passed by the house in which it originated,
- 2 or in which amendments thereto shall have originated, shall
- 3 immediately be certified by the presiding officer and clerk and
- 4 sent to the other house for consideration.
- 5 Any bill pending at the final adjournment of a regular
- 6 session in an odd-numbered year shall carry over with the same
- 7 status to the next regular session. Before the carried-over
- 8 bill is enacted, it shall pass at least one reading in the house
- 9 in which the bill originated.
- 10 Passage of legislation proposing to increase the rates for
- 11 any tax collected by the State or to enact a new tax to be
- 12 collected by the State shall require a two-thirds vote of all
- 13 members to which each house is entitled."
- 14 Passage of legislation proposing to increase the state
- 15 minimum wage shall require a two-thirds vote of all members to
- 16 which each house is entitled."
- 17 SECTION 3. The question to be printed on the ballot shall
- 18 be as follows:
- "Shall the Constitution be amended to include a two-thirds
- 20 supermajority voting requirement for the legislature to pass

- 3 SECTION 4. New constitutional material is underscored.
- 4 SECTION 5. This amendment shall take effect upon
- 5 compliance with Article XVII, section 3, of the Constitution of
