# A BILL FOR AN ACT

RELATING TO HOMELAND SECURITY.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 128A, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§128A- Hawaii state fusion center. (a) There is
- 5 established the Hawaii state fusion center in the office of
- 6 homeland security. The director of homeland security, subject
- 7 to the direction and control of the governor, shall oversee the
- 8 Hawaii state fusion center.
- 9 (b) There shall be a Hawaii state fusion center director
- 10 who shall be appointed, and may be removed, by the director of
- 11 homeland security. The director of the Hawaii state fusion
- 12 center shall be responsible for the day-to-day operations of the
- 13 Hawaii state fusion center. The director of the Hawaii state
- 14 fusion center shall be exempt from chapter 76, and the position
- 15 shall be funded by the State.
- 16 (c) The Hawaii state fusion center shall:

1	(1)	Be continually staffed to	monitor all crimes and
2		hazards and shall be the	focal point for sharing
3		local, national, and inte	ernational information and
4		context with the national	level intelligence
5		community;	
6	(2)	Collaborate among all lev	rels of government to receive,
7		analyze, and disseminate	threat-related information in
8		coordination with multi-d	disciplinary partners; and
9	(3)	Establish a joint integra	tion center to:
10		(A) Integrate information	on technology, cybersecurity,
11		and cybercrime preve	ention, and cyber and analytic
12		capabilities, and to	o improve situational
13		awareness related to	critical infrastructure or
14		key resources protec	tion of lifelines;
15		(B) Coordinate with loca	l, state, and federal
16		agencies for asset r	esponse activities to
17		include:	
18		(i) Furnishing tech	nical assistance to affected
19		entities to pro	tect their assets, mitigate
20		vulnerabilities	, and reduce impacts of cyber
21		incidents;	

1	<u>(ii)</u>	Identifying other entities that may be at
2		risk and assessing their risk to the same or
3		similar vulnerabilities;
4	<u>(iii)</u>	Assessing potential risks to the State or
5		region, including potential cascading
6		effects, and developing courses of action to
7		mitigate these risks;
8	<u>(iv)</u>	Facilitating information sharing and
9		operational coordination to respond to
10		threats; and
11	<u>(v)</u>	Providing guidance as to how best to utilize
12		federal resources and capabilities in a
13		timely, effective manner to speed recovery;
14		and
15	(C) Provi	de intelligence support and related
16	activ	vities, facilitate the building of
17	situa	ational threat awareness and sharing of
18	relat	ted intelligence, including the integrated
19	analy	sis of threat trends and events, the
20	ident	ification of knowledge gaps, and the ability

1		to degrade or mitigate adversary threat
2		capabilities."
3	SECT	ION 2. Section 76-16, Hawaii Revised Statutes, is
4	amended b	y amending subsection (b) to read as follows:
5	"(b)	The civil service to which this chapter applies shall
6	comprise	all positions in the State now existing or hereafter
7	establish	ed and embrace all personal services performed for the
8	State, ex	cept the following:
9	(1)	Commissioned and enlisted personnel of the Hawaii
10		National Guard as such, and positions in the Hawaii
11		National Guard that are required by state or federal
12		laws or regulations or orders of the National Guard to
13		be filled from those commissioned or enlisted
14		personnel;
15	(2)	Positions filled by persons employed by contract where
16		the director of human resources development has
17		certified that the service is special or unique or is
18		essential to the public interest and that, because of
19		circumstances surrounding its fulfillment, personnel
20		to perform the service cannot be obtained through

1		normal civil service recruitment procedures. Any such
2		contract may be for any period not exceeding one year;
3	(3)	Positions that must be filled without delay to comply
4		with a court order or decree if the director
5		determines that recruitment through normal recruitment
6		civil service procedures would result in delay or
7		noncompliance, such as the Felix-Cayetano consent
8		decree;
9	(4)	Positions filled by the legislature or by either house
10		or any committee thereof;
11	(5)	Employees in the office of the governor and office of
12		the lieutenant governor, and household employees at
13		Washington Place;
14	(6)	Positions filled by popular vote;
15	(7)	Department heads, officers, and members of any board,
16		commission, or other state agency whose appointments
17		are made by the governor or are required by law to be
18		confirmed by the senate;
19	(8)	Judges, referees, receivers, masters, jurors, notaries
20		public, land court examiners, court commissioners, and

(9) One bailiff for the chief justice of the supreme court who shall have the powers and duties of a court officer and bailiff under section 606-14; one secretary or clerk for each justice of the supreme court, each judge of the intermediate appellate court, and each judge of the circuit court; one secretary for the judicial council; one deputy administrative director of the courts; three law clerks for the chief justice of the supreme court, two law clerks for each associate justice of the supreme court and each judge of the intermediate appellate court, one law clerk for each judge of the circuit court, two additional law clerks for the civil administrative judge of the circuit court of the first circuit, two additional law clerks for the criminal administrative judge of the circuit court of the first circuit, one additional law clerk for the senior judge of the family court of the first circuit, two additional law clerks for the civil motions judge of the circuit court of the first

3	(B)	Effective July 1, 2003, teaching assistants,

7		athletic health care trainers, alternative school
8		work study assistants, alternative school
9		educational/supportive services specialists,
10		alternative school project coordinators, and
11		communications aides in the department of
12		education;
13	(C)	The special assistant to the state librarian and
14		one secretary for the special assistant to the
15		state librarian; and
16	(D)	Members of the faculty of the University of
17		Hawaii, including research workers, extension
18		agents, personnel engaged in instructional work,
19		and administrative, professional, and technical
20		personnel of the university;

1	(12)	Empl	oyees engaged in special, research, or
2		demo	enstration projects approved by the governor;
3	(13)	(A)	Positions filled by inmates, patients of state
4			institutions, persons with severe physical or
5			mental disabilities participating in the work
6			experience training programs;
7		(B)	Positions filled with students in accordance with
8			guidelines for established state employment
9			programs; and
10		(C)	Positions that provide work experience training
11			or temporary public service employment that are
12			filled by persons entering the workforce or
13			persons transitioning into other careers under
14			programs such as the federal Workforce Investment
15			Act of 1998, as amended, or the Senior Community
16			Service Employment Program of the Employment and
17			Training Administration of the United States
18			Department of Labor, or under other similar state
19			programs;
20	(14)	A cu	stodian or guide at Iolani Palace, the Royal
21		Maus	soleum, and Hulihee Palace;

Ţ	(15)	Positions filled by persons employed on a fee,
2		contract, or piecework basis, who may lawfully perform
3		their duties concurrently with their private business
4		or profession or other private employment and whose
5		duties require only a portion of their time, if it is
6		impracticable to ascertain or anticipate the portion
7		of time to be devoted to the service of the State;
8	(16)	Positions of first deputies or first assistants of
9		each department head appointed under or in the manner
10		provided in section 6, article V, of the Hawaii State
11		Constitution; three additional deputies or assistants
12		either in charge of the highways, harbors, and
13		airports divisions or other functions within the
14		department of transportation as may be assigned by the
15		director of transportation, with the approval of the
16		governor; four additional deputies in the department
17		of health, each in charge of one of the following:
18		behavioral health, environmental health, hospitals,
19		and health resources administration, including other
20		functions within the department as may be assigned by
21		the director of health, with the approval of the

1		governor; an administrative assistant to the state
2		librarian; and an administrative assistant to the
3		superintendent of education;
4	(17)	Positions specifically exempted from this part by any
5		other law; provided that:
6		(A) Any exemption created after July 1, 2014, shall
7		expire three years after its enactment unless
8		affirmatively extended by an act of the
9		legislature; and
10		(B) All of the positions defined by paragraph (9)
11		shall be included in the position classification
12		plan;
13	(18)	Positions in the state foster grandparent program and
14		positions for temporary employment of senior citizens
15		in occupations in which there is a severe personnel
16		shortage or in special projects;
17	(19)	Household employees at the official residence of the
18		president of the University of Hawaii;
19	(20)	Employees in the department of education engaged in
20		the supervision of students during meal periods in the
21		distribution, collection, and counting of meal

1		tickets, and in the cleaning of classrooms after
2		school hours on a less than half-time basis;
3	(21)	Employees hired under the tenant hire program of the
4		Hawaii public housing authority; provided that not
5		more than twenty-six per cent of the authority's
6		workforce in any housing project maintained or
7		operated by the authority shall be hired under the
8		tenant hire program;
9	(22)	Positions of the federally funded expanded food and
10		nutrition program of the University of Hawaii that
11		require the hiring of nutrition program assistants who
12		live in the areas they serve;
13	(23)	Positions filled by persons with severe disabilities
14		who are certified by the state vocational
15		rehabilitation office that they are able to perform
16		safely the duties of the positions;
17	(24)	The sheriff;
18	(25)	A gender and other fairness coordinator hired by the
19		judiciary;
20	(26)	Positions in the Hawaii National Guard youth and adult
71		education programs:

1	(27)	In the state energy office in the department of
2		business, economic development, and tourism, all
3		energy program managers, energy program specialists,
4		energy program assistants, and energy analysts;
5	(28)	Administrative appeals hearing officers in the
6		department of human services;
7	(29)	In the Med-QUEST division of the department of human
8		services, the division administrator, finance officer,
9		health care services branch administrator, medical
10		director, and clinical standards administrator;
11	(30)	In the director's office of the department of human
12		services, the enterprise officer, information security
13		and privacy compliance officer, security and privacy
14		compliance engineer, and security and privacy
15		compliance analyst;
16	(31)	The Alzheimer's disease and related dementia services
17		coordinator in the executive office on aging;
18	(32)	In the Hawaii emergency management agency, the
19		executive officer, public information officer, civil
20		defense administrative officer, branch chiefs, and
21		emergency operations center state warning point

1	personnel; provided that, for state warning point
2	personnel, the director shall determine that
3	recruitment through normal civil service recruitment
4	procedures would result in delay or noncompliance;

6	<pre>{](33)[}]The executive director and seven full-time</pre>
7	administrative positions of the school facilities
8	authority[-]; and
9	(34) The director of the Hawaii state fusion center.
10	The director shall determine the applicability of this
11	section to specific positions.
12	Nothing in this section shall be deemed to affect the civil
13	service status of any incumbent as it existed on July 1, 1955."
14	SECTION 3. Statutory material to be repealed is bracketed
15	and stricken. New statutory material is underscored.
16	SECTION 4. This Act shall take effect on July 1, 2050.
