HOUSE CONCURRENT RESOLUTION

REQUESTING THE CREATION AND ESTABLISHMENT OF A TASK FORCE WITHIN THE JUDICIARY TO DETERMINE THE FEASIBILITY OF AND BEST SYSTEM TO TRANSMIT SERVICE OF NOTICE AND PROCESS VIA ELECTRONIC EMAIL.

WHEREAS, technology has become increasingly prevalent as a means of communication and is more accessible than ever before; and

WHEREAS, service of notice and process in non-criminal proceedings cannot currently be transmitted through electronic mail; and

WHEREAS, electronic mail could be an easier and more efficient means of serving notice and process; and

WHEREAS, however, there could also be unforeseen complications with electronic mail, such as an inability to access technology, unsuccessful delivery, or evasion of confirmation of service; and

WHEREAS, a task force could identify unforeseen complications and develop a system to best transmit service of notice and process via electronic mail; now, therefore,

BE IT RESOLVED by the House of Representatives of the Thirty-first Legislature of the State of Hawaii, Regular Session of 2022, the Senate concurring, that a task force is requested to be created and established within the Judiciary to determine the feasibility of and best system to transmit service of notice and process via electronic email; and
