
HOUSE CONCURRENT RESOLUTION

REQUESTING THE BOARD OF EDUCATION AND DEPARTMENT OF EDUCATION TO
ESTABLISH THE POSITION OF ADMINISTRATIVE VICE PRINCIPAL
DEAN OF STUDENTS FOR THE LAHAINALUNA HIGH SCHOOL BOARDING
PROGRAM.

1 WHEREAS, Lahainaluna High School is a public school located
2 on the Island of Maui that serves approximately one thousand
3 students; and

4
5 WHEREAS, the Lahainaluna High School Boarding Program,
6 founded in 1836, offers students the opportunity to take
7 advantage of the school's academic offerings and the many
8 community, club, athletic, and work programs; and

9
10 WHEREAS, the Lahainaluna High School Boarding Program
11 welcomes students from across the State and internationally who
12 are interested in a Lahainaluna education and boarding life
13 experience; and

14
15 WHEREAS, the Lahainaluna High School Boarding Program is
16 committed to its students and their development as leaders and
17 self-sustaining contributors to society; and

18
19 WHEREAS, the management of the Lahainaluna High School
20 Boarding Program poses a unique endeavor that traditionally
21 trained principals may not be experienced in; and

23 WHEREAS, a Lahainaluna Boarding Department Working Group
24 was convened in October of 2014 to develop a vision, mission,
25 and purpose for the Lahainaluna High School Boarding Program;

1 WHEREAS, the Lahainaluna Boarding Department Working Group
2 made several recommendations for the Lahainaluna High School
3 Boarding Program, including:

- 5 (1) Continuing funding for the Boarding Program;

 - 7 (2) Implementing certain programs and courses that provide
8 direction to give the Boarding Program the capacity to
9 move forward into the future;

 - 11 (3) Enhancing and sustaining the system of the living
12 center experiences and the hands-on, project-based
13 learning experiences of the Boarding Program geared
14 for the 21st century and founded in the culture of
15 Hawai'i, providing a highly unique educational
16 experience not available through any other public high
17 school;

 - 19 (4) Exploring a public-private partnership to procure and
20 install a sustainable alternative renewable energy
21 system for the Boarding Program facilities to
22 eliminate the high cost of electricity required for
23 the Boarding Program; and

 - 25 (5) Expanding community and alumni partnerships to augment
26 funding for the Boarding Program; and

28 WHEREAS, an administrative vice principal dean of students
29 for the Lahainaluna High School Boarding Program will create a
30 point position to implement immediate oversight and staffing
31 needs for the Boarding Program; and

33 WHEREAS, an administrative vice principal dean of students
34 for the Lahainaluna High School Boarding Program will also allow
35 for the implementation of the Lahainaluna Boarding Department
36 Working Group's recommendations and provide coordination for the
37 Boarding Program to better respond to the Boarding Program
38 students' needs; now, therefore,

40 BE IT RESOLVED by the House of Representatives of the
41 Thirty-first Legislature of the State of Hawaii, Regular Session
42 of 2022, the Senate concurring, that the Board of Education and



1 Department of Education are requested to establish one full-time
2 equivalent (1.00 FTE) position of administrative vice principal
3 dean of students for the Lahainaluna High School Boarding
4 Program; and

6 BE IT FURTHER RESOLVED that the Board of Education and
7 Department of Education are requested to include in its budget
8 request to the Legislature funding for the administrative vice
9 principal dean of students for the Lahainaluna High School
10 Boarding Program; and

12 BE IT FURTHER RESOLVED that the Board of Education and
13 Department of Education are requested to include in the
14 responsibilities of administrative vice principal dean of
15 students for the Lahainaluna High School Boarding Program that
16 the administrative vice principal dean of students shall:

- 18 (1) Run and staff the Boarding Program;

- 20 (2) Increase recruitment of students for the Boarding
- 21 Program;

- 23 (3) Establish student programs and vocational
- 24 opportunities for the Boarding Program; and

- 26 (4) Implement the recommendations of the Lahainaluna
- 27 Boarding Program Working Group as stated in its
- 28 October 2015 report; and

31 BE IT FURTHER RESOLVED that certified copies of this
32 Concurrent Resolution be transmitted to Chairperson of the Board
33 of Education, Interim Superintendent of Education, and Principal
34 of Lahainaluna High School.
