
HOUSE RESOLUTION

ENCOURAGING THE DEPARTMENT OF TRANSPORTATION TO WORK WITH
STAKEHOLDERS TO DEVELOP A HOLISTIC MANAGEMENT PLAN THAT
WILL ENSURE HANA HIGHWAY IS PROPERLY MAINTAINED AND IS SAFE
FOR RESIDENTS AND VISITORS.

1 WHEREAS, in 2000, in recognition of its status an
2 internationally renowned roadway, former U.S. President Bill
3 Clinton designated Hana Highway as the Hana Millennium Legacy
4 Trail; and

5
6 WHEREAS, in 2001 Hana Highway was listed on the National
7 Register of Historical Places; and

8
9 WHEREAS, the Hawaii Tourism Authority is tasked with
10 attracting "responsible high-value mindful travelers" who will
11 value the natural resources of Hawaii; and

12
13 WHEREAS, Hana Highway is fifty-two miles long, with six
14 hundred seventeen switchbacks, fifty-six one-lane bridges and
15 several drops of more than one thousand feet, however it lacks
16 adequate guard rails; and

17
18 WHEREAS, approximately a half mile past the six-mile marker
19 is a sharp U-curve in the road, going uphill along one-lane,
20 with a brick wall on one side, with virtually no space to safely
21 maneuver around other vehicles on the roadway and often steep
22 drop offs; and

23
24 WHEREAS, emergency medical technicians working at station
25 medic six in Hana have testified as to the "extreme increase in
26 the number of cars" that have led to delays for the only
27 ambulance in East Maui, which is responsible for transporting
28 patients to Maui Memorial Medical Center or responding to
29 emergency calls in the community; and

1 WHEREAS, these delays have been associated with increased
2 visitor traffic, a lack of visitor knowledge, and rental cars
3 not pulling over to make way for the emergency vehicles; and
4

5 WHEREAS, the increase in traffic in Hana has also led to an
6 increase in the need for emergency services for visitors, who
7 reportedly need rescuing because they are wearing improper
8 footwear or they have no idea how to manage the trail, which
9 increases the number of patients requiring emergency evacuation
10 utilizing Hana Highway; and
11

12 WHEREAS, between June 1 and June 23 of 2021, the Maui
13 Police Department issued three hundred eighty-nine parking
14 citations and eighty-three warnings to violators on Hana
15 Highway, between the towns of Haiku and Hana; and
16

17 WHEREAS, during Maui County Council meetings in 2021, a
18 majority of those who testified expressed support for increased
19 law enforcement on Hana Highway; and
20

21 WHEREAS, despite the community call for increased law
22 enforcement, Maui Police Department reported that the Department
23 is operating with fewer officers; and
24

25 WHEREAS, Maui Police Department has asked for assistance
26 from the Sheriff Division of the Department of Public Safety and
27 Division of Conservation and Resources Enforcement of the
28 Department of Land and Natural Resources; and
29

30 WHEREAS, the Chief of Police of the Maui Police Department
31 has publicly stated that the Maui Police Department is "over-
32 taxed and short-handed"; and
33

34 WHEREAS, due to the lack of law enforcement, much of the
35 daily enforcement and safety efforts are being conducted by a
36 civil volunteer group of residents, commercial ground
37 transportation carriers and activity providers, referred to as
38 the Hana Highway Regulation; and

40 WHEREAS, the Hana Highway Regulation civil volunteer group
41 has been engaged in efforts to maintain and ensure roadway
42 safety on Hana Highway since 2016; and



1
2 WHEREAS, the Hana Highway Regulation civil volunteer group
3 published a "Code of Conduct" in 2017; and
4

5 WHEREAS, in 2018 the Hana Highway Regulation civil
6 volunteer group initiated the Hana Pono Visitor Pledge and Hana
7 Pono Commercial Operators Certification Program; and
8

9 WHEREAS, based on the five years of data gathered by the
10 Hana Highway Regulation civil volunteer group, a report entitled
11 "Road to Hana Problems and Solutions" was published,
12 highlighting the group's progress and what they consider to be
13 actions necessary to ensure the long-term viability of Hana
14 Highway; and
15

16 WHEREAS, in 2021 the Hana Highway Regulation civil
17 volunteer group engaged in a pilot project with the Office of
18 Economic Development of the County of Maui, referred to as the
19 Road to Hana Visitor Information Personnel Pilot Project; and
20

21 WHEREAS, since the Hana Highway pilot project has been
22 implemented, the Hana Highway Regulation civil volunteer group
23 reports a ninety-six percent decrease in illegal parking and
24 trespassing on private lands; and
25

26 WHEREAS, there has been historic difficulty in maintaining
27 Hana Highway due to physical location, as well as the multiple
28 parties owning adjacent lands; and
29

30 WHEREAS, in order to improve road safety for residents and
31 visitors, it is necessary for the Department of Transportation
32 to work with all stakeholders to ensure that Hana Highway is
33 properly maintained and to ensure the safety of residents and
34 visitors; now, therefore,
35

36 BE IT RESOLVED by the House of Representatives of the
37 Thirty-first Legislature of the State of Hawaii, Regular Session
38 of 2022, that the Department of Transportation is encouraged to
39 work with the following to develop a holistic management plan
40 that will ensure Hana Highway is properly maintained and is safe
41 for residents and visitors:
