As required by HRS § 37-52.5(a), the Judiciary respectfully submits this report to the Legislature on the following administratively established new accounts.

Appropriation No. S-22-233-J Ballistic Vests for POs (FY22)

Award Amount: \$24,292.40

Justification for the establishment of the account or fund: Ballistic vests have a warranty of five (5) years. All of the ACSB ballistic vest warranties expired in 2020. This grant will be used to provide the ballistic vests to POs, so that they are able to conduct home checks safely.

Source of revenue for the fund: U.S. Department of Justice, through the State of Hawai'i Department of the Attorney General CPJAD CFDA No.: 16.738

Appropriation No. S-22-236-J Judiciary DWI Court (FY22)

Award Amount: \$91,549.00

Justification for the establishment of the account or fund: To support operation of the DWI Court Program in the District Court of the First Circuit by enhancing resources available to supervise program participants, increasing training opportunities for program staff, and expanding data collection.

Source of revenue for the fund: National Highway Traffic Safety Administration FAST Act, through Hawai'i DOT CFDA No.: 20.607, 20.608, and 20.616

Appropriation No. S-22-239-J State Access and Visitation Program (FY22)

Award Amount: \$100,000.00

Justification for the establishment of the account or fund: To help increase noncustodial parents' access to time with their children.

Source of revenue for the fund: U.S. Department of Health and Human Services (DHHS), Administration for Children & Families (ACF), CFDA No.: 93.597

Appropriation No. S-22-289-J Judiciary National Criminal History Improvement Program (NCHIP FY21)

Award Amount: \$42,000.00

Justification for the establishment of the account or fund: To provide improvements in the accuracy, quality, timeliness, immediate accessibility, and integration of national systems of criminal history and related records.

Source of revenue for the fund: Bureau of Justice Statistics through the Hawai'i Criminal Justice Data Center (HCJDC) CFDA No.: 16.554
