### A BILL FOR AN ACT

RELATING TO ROBBERY IN THE FIRST DEGREE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State's penal
- 2 code does not adequately address potential situations in which
- 3 offenders will utilize electric guns to facilitate crimes. On
- 4 January 1, 2022, it became legal for many members of the public
- 5 to buy and possess electric guns.
- 6 Electric guns can cause severe pain and completely
- 7 incapacitate a person. Criminals will begin to use these
- 8 devices against others to facilitate crimes as they become more
- 9 prevalent in the community. While the effect of electric guns
- 10 can be severe, the incapacitation can also be momentary and may
- 11 not result in death or serious bodily injury. Once the use of
- 12 an electric gun against a person stops, it is likely that the
- 13 residual injuries would be lesser than would occur had a similar
- 14 level of incapacitation or pain been inflicted on a victim by
- 15 other means.
- 16 The penal code frequently utilizes residual injury or
- 17 incapacitation as a key determining factor for the level of

- 1 severity and resulting penalty for a crime. Electric guns will
- 2 allow criminals to achieve unprecedented incapacitation of a
- 3 person and potentially avoid residual injury to the victim,
- 4 resulting in lower penalties for the crime.
- 5 For these reasons, the legislature further finds that
- 6 specifying the use or threatened use of an electric gun during
- 7 the course of committing a robbery under this particular offense
- 8 is necessary and may have a long-term deterrent effect that
- 9 creates a safer environment for the community.
- 10 Accordingly, the purpose of this Act is to amend the
- 11 offense of robbery in the first degree to include as part of
- 12 this offense being armed with or using an electric gun during
- 13 the course of a theft.
- 14 SECTION 2. Section 708-840, Hawaii Revised Statutes, is
- 15 amended by amending subsections (1) and (2) to read as follows:
- 16 "(1) A person commits the offense of robbery in the first
- 17 degree if, in the course of committing theft or non-consensual
- 18 taking of a motor vehicle:
- 19 (a) The person attempts to kill another or intentionally
- or knowingly inflicts or attempts to inflict serious
- 21 bodily injury upon another;

1 governor or mayor pursuant to chapter 127A, within the 2 area covered by the emergency or disaster. 3 As used in this section: 4 "Dangerous instrument" means any firearm, whether loaded or 5 not, and whether operable or not, or other weapon, device, 6 instrument, material, or substance, whether animate or 7 inanimate, which in the manner it is used or threatened to be 8 used is capable of producing death or serious bodily injury. 9 "Electric gun" shall have the same meaning as in section 10 134-81. 11 "Simulated firearm" means any object that: 12 Substantially resembles a firearm; (a) 13 (b) Can reasonably be perceived to be a firearm; or 14 Is used or brandished as a firearm." (C) SECTION 3. This Act does not affect rights and duties that 15 matured, penalties that were incurred, and proceedings that were 16 17 begun before its effective date.
