A BILL FOR AN ACT

RELATING TO THE USE OF SIRENS BY EMERGENCY VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the use of sirens by
- 2 emergency vehicles can be necessary to alert other vehicles and
- 3 pedestrians that the emergency vehicle is exercising its
- 4 authority to disregard certain traffic laws, such as proceeding
- 5 through a red light or exceeding the posted speed limit. The
- 6 legislature further finds that some emergency response sectors
- 7 have determined that there should be flexibility to not engage
- 8 the siren in situations where it is unnecessary, such as
- 9 responding at night when the streets are empty of cars and
- 10 pedestrians. Further, the city and county of Honolulu has
- 11 expressed in its ordinances that the siren should be used "as
- 12 may be reasonably necessary". Despite this, some emergency
- 13 response sectors believe that the use of the siren is mandatory
- 14 in all circumstances. The legislature notes that the
- 15 unnecessary use of a siren contributes to noise pollution,
- 16 especially in heavily-congested residential areas.

- 1 Accordingly, the purpose of this measure is to provide
- 2 flexibility in the use of sirens by emergency response vehicles
- 3 in certain circumstances.
- 4 SECTION 2. Section 291C-26, Hawaii Revised Statutes, is
- 5 amended to read as follows:
- 6 "\$291C-26 Authorized emergency vehicles. (a) The driver
- 7 of an authorized emergency vehicle, when responding to an
- 8 emergency call or when in the pursuit of an actual or suspected
- 9 violator of the law or when responding to but not upon returning
- 10 from a fire alarm and vehicles used by police officers while in
- 11 the performance of a police function, may exercise the
- 12 privileges set forth in this section, but subject to the
- 13 conditions herein stated.
- 14 (b) The driver of an authorized emergency vehicle may:
- 15 (1) Park or stand irrespective of the provisions of this
- 16 chapter;
- 17 (2) Proceed past a red or stop signal or stop sign, but
- only after slowing down as may be necessary for safe
- 19 operation;
- 20 (3) Exceed the maximum speed limits so long as the driver
- 21 does not endanger life or property;

1	(4)	Disregard regulations governing direction of movement
2		or turning in specified directions;
3	(5)	Drive on the shoulder and median of roadways; and
4	(6)	Drive in controlled-access roadways, highways, and
5		facilities.
6	(c)	The exemptions granted in subsection (b) to an
7	authorized emergency vehicle shall apply only when the vehicle	
8	is making	use of authorized audible and visual signals[, except
9	as otherwise provided by county ordinance.]; provided that use	
10	of an aut	horized audible signal shall not be required if it is
11	not reasonably necessary under the circumstances. This	
12	subsection shall not apply to police vehicles.	
13	(d)	The foregoing provisions shall not relieve the driver
14	of an aut	horized emergency vehicle from the duty to drive with
15	due regar	d for the safety of all persons, nor shall those
16	provisions protect the driver from the consequences of the	
17	driver's	reckless disregard for the safety of others."
