
A BILL FOR AN ACT

RELATING TO DIGITAL LITERACY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that, according to a 2015
2 report by the Association of Library Service to Children,
3 library services increasingly center on digital tools and media.
4 In 2015, seventy-five per cent of households owned some form of
5 digital media device. However, guidance and knowledge on the
6 use of digital media is often lacking. Providing parents and
7 children with a deeper understanding of the digital tools
8 available to them is essential to the well-being of families in
9 the twenty-first century.

10 The legislature further finds that digital literacy skills
11 are crucial for career success in the twenty-first century.
12 According to a Brookings Institution report from 2017,
13 workplaces across the country and globe have undergone a rapid
14 process of digitization. The percentage of workplaces with high
15 levels of digital content has grown dramatically in recent
16 years, while the percentage of workplaces that rely on a lower
17 level of digital content has decreased by a similarly dramatic



1 margin. While digitization offers advantages to individuals
 2 with extensive digital literacy, it also increases barriers for
 3 members of the public who lack digital skills. Increasing
 4 digital literacy among members of the public would increase
 5 their competitiveness in an economy increasingly defined by the
 6 ability to use digital tools.

7 The purpose of this Act is to increase access to digital
 8 tools and promote digital literacy by establishing a digital
 9 literacy program to be administered by the board of education
 10 through the state librarian.

11 SECTION 2. Chapter 312, Hawaii Revised Statutes, is
 12 amended by adding a new section to be appropriately designated
 13 and to read as follows:

14 "§312- Digital literacy program. (a) In addition to
 15 its other duties, the board of education, through the state
 16 librarian, shall:

- 17 (1) Provide for the establishment and ongoing operation of
 18 a digital literacy program for the public libraries in
 19 the State; and
- 20 (2) Provide coordination and facilitation of the
 21 activities of digital literacy service providers and



1 digital literacy programs in the public, private, and
2 volunteer sectors.

3 (b) The objectives of the digital literacy program shall
4 be to provide programmatic activities promoting digital learning
5 in the community by providing digital skill building
6 opportunities, which shall aim to:

7 (1) Improve knowledge and skill in digital literacy;

8 (2) Improve knowledge and skill in the use of digital
9 education tools and platforms; and

10 (3) Increase knowledge, skill, and use of tools and
11 platforms to make digital technology accessible to
12 individuals with disabilities.

13 (c) The digital literacy program shall not affect existing
14 department of education programs relating to adult education as
15 provided under sections 302A-432 to 302A-435."

16 SECTION 3. There is appropriated out of the general
17 revenues of the State of Hawaii the sum of \$ or so
18 much thereof as may be necessary for fiscal year 2022-2023 for
19 the establishment and administration of the digital literacy
20 program created by this Act, and to fund one full-time
21 equivalent (1.0 FTE) position to be placed within the Hawaii



1 State public library system to administer the digital literacy
2 program created by this Act.

3 The sum appropriated shall be expended by the Hawaii State
4 public library system for the purposes of this Act.

5 SECTION 4. New statutory material is underscored.

6 SECTION 5. This Act shall take effect on July 1, 2022.
