A BILL FOR AN ACT

RELATING TO TRANSIT ORIENTED DEVELOPMENT DISTRICTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) The department of business, economic
- 2 development, and tourism, in consultation with all appropriate
- 3 state and county agencies to be determined by the governor,
- 4 shall conduct a study of infrastructure needs in transit
- 5 oriented development districts.
- **6** (b) The study shall propose projects to be undertaken by
- 7 the State using funds issued under United States Public Law 117-
- 8 58, commonly referred to as the Infrastructure Investment and
- 9 Jobs Act, to address the lack of sufficient infrastructure in
- 10 transit oriented development districts to support high density
- 11 living. Projects proposed pursuant to this subsection shall
- 12 contribute to the State's efforts to meet its affordable housing
- 13 goals established in Act 127, Session Laws of Hawaii 2016.
- 14 (c) The department of business, economic development, and
- 15 tourism shall submit a report of its findings and
- 16 recommendations, including any proposed legislation, to the

- 1 legislature no later than twenty days prior to the convening of
- 2 the regular session of 2023.
- 3 SECTION 2. State departments and county agencies that
- 4 receive funds through Infrastructure Investment and Jobs Act
- 5 shall prioritize using those funds to implement projects in
- 6 transit oriented development districts that meaningfully
- 7 contribute to the State's affordable housing goals established
- 8 in Act 127, Session Laws of Hawaii 2016.
- 9 SECTION 3. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$ or so
- 11 much thereof as may be necessary for fiscal year 2022-2023 for
- 12 the department of business, economic development, and tourism to
- 13 conduct a study of necessary infrastructure in transit oriented
- 14 development districts.
- 15 The sum appropriated shall be expended by the department of
- 16 business, economic development, and tourism for the purposes of
- 17 this Act.
- 18 SECTION 4. This Act shall take effect on July 1, 2022.
