# A BILL FOR AN ACT

RELATING TO CHIEF PROCUREMENT OFFICERS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that it is a matter of  
2 statewide concern that the president of the University of Hawaii  
3 serves simultaneously as the chief procurement officer for the  
4 University of Hawaii system. The president of the system  
5 simultaneously serving as the chief procurement officer leads to  
6 inevitable conflicts of interest.

7           The legislature further finds that across the United  
8 States, the vast majority of public higher education  
9 institutions, including the California State University System,  
10 University of Massachusetts System, and University of Oregon  
11 System, differentiate between institutional leadership and  
12 purchasing when assigning the authority over procurement. While  
13 the chief procurement officer for the Colorado State University  
14 System possesses authority over state purchasing and procurement  
15 as well as direct oversight over Colorado's institutions of  
16 higher learning, there were no instances in institutions across



1 the country that had a university president concurrently named  
2 as chief procurement officer.

3 Accordingly, the purpose of this Act is to designate the  
4 vice president of budget and finance and the chief financial  
5 officer as the chief procurement officer for the University of  
6 Hawaii.

7 SECTION 2. Section 103D-203, Hawaii Revised Statutes, is  
8 amended by amending subsection (a) to read as follows:

9 "(a) The chief procurement officer for each of the  
10 following state entities shall be:

- 11 (1) The judiciary--the administrative director of the  
12 courts;
- 13 (2) The senate--the president of the senate;
- 14 (3) The house of representatives--the speaker of the house  
15 of representatives;
- 16 (4) The office of Hawaiian affairs--the chairperson of the  
17 board;
- 18 (5) The University of Hawaii-- [~~the president of the~~  
19 ~~University of Hawaii;~~] the vice president for budget  
20 and finance and chief financial officer;



- 1           (6) The department of education, excluding the Hawaii  
2           public library system--the superintendent of  
3           education;
- 4           (7) The Hawaii health systems corporation--the chief  
5           executive officer of the Hawaii health systems  
6           corporation; and
- 7           (8) The remaining departments of the executive branch of  
8           the State and all governmental bodies administratively  
9           attached to them--the administrator of the state  
10          procurement office of the department of accounting and  
11          general services."

12          SECTION 3. Statutory material to be repealed is bracketed  
13          and stricken. New statutory material is underscored.

14          SECTION 4. This Act shall take effect upon its approval;  
15          provided that the amendments made to section 103D-203, Hawaii  
16          Revised Statutes, by section 2 of this Act shall not be repealed  
17          when that section is reenacted on June 30, 2024, pursuant to  
18          section 16 of Act 8, Special Session Laws of Hawaii 2021.
