A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Reinventing
- 2 Education Act of 2004 (Act 51, Session Laws of Hawaii 2004)
- 3 established a weighted student formula to allocate moneys to
- 4 schools according to the different costs of educating students
- 5 with varying needs. Despite the intended equitable distribution
- 6 of funds, the legislature finds that the weighted student
- 7 formula has placed small, remote schools at a disadvantage. In
- 8 the case of Hana high and elementary school, the budgetary
- 9 shortfall has resulted in the loss of several well-qualified
- 10 teachers and has threatened the school's ability to offer
- 11 minimum course requirements for students to earn high school
- 12 diplomas. If Hana high school is unable to offer its students
- 13 the requisite courses for graduation, those students will have
- 14 to endure a nearly forty-mile, two-hour drive to the next
- 15 closest public high school, King Kekaulike high school.
- 16 The legislature further finds that despite the current
- 17 economic situation, remote schools should be funded to retain

- 1 the minimal personnel and resources necessary to allow students
- 2 to graduate. One way to address this is to allow these schools
- 3 to receive supplemental funding based on their remote status.
- 4 The purpose of this Act is to authorize supplemental
- 5 categorical funding for remote schools.
- 6 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 7 amended by adding a new section to part V, subpart B, to be
- 8 appropriately designated and to read as follows:
- 9 "§302A- Remote schools categorical funding. (a)
- 10 Subject to legislative appropriations, a remote school may
- 11 receive supplemental categorical funding to support additional
- 12 instructional and support staff.
- 13 (b) Any supplemental categorical funding provided to a
- 14 remote school pursuant to this section shall be in addition to
- 15 the allocation determined under the weighted student formula
- 16 that is made to the remote school.
- 17 (c) For the purpose of this section, "remote school" means
- 18 any public school, as defined in section 302A-101, except
- 19 charter schools governed by chapter 302D, that is a high school:
- 20 (1) Located at least a one-hour drive away from the next
- 21 nearest public high school; or

- 1 (2) Located on the island of Lanai, Molokai, or Niihau;
- 2 provided that if the high school is combined with an elementary,
- 3 middle, intermediate, or other lower level of schooling, that
- 4 entire school shall be deemed a remote school for the purpose of
- 5 this section; provided further that "remote school" shall
- 6 include Kaunakakai elementary school, Kilohana elementary
- 7 school, Maunaloa elementary school, and Molokai middle school."
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so
- 10 much thereof as may be necessary for fiscal year 2022-2023 for
- 11 remote schools categorical funding pursuant to this Act.
- The sum appropriated shall be expended by the department of
- 13 education for the purposes of this Act.
- 14 SECTION 4. New statutory material is underscored.
- 15 SECTION 5. This Act shall take effect on July 1, 2022.
