A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that homelessness in
- 2 Hawaii is a long-term problem. The legislature acknowledges
- 3 that homelessness requires greater collaboration and
- 4 coordination among diverse government entities, businesses,
- 5 nonprofit organizations, and faith-based organizations. In
- 6 pursuit of this goal, the legislature enacted Act 105, Session
- 7 Laws of Hawaii 2012 (Act 105). Act 105, in part, formally
- 8 established the Hawaii interagency council on homelessness,
- 9 which had been temporarily created through Executive Order No.
- 10 11-21. Act 105 allowed the council to continue identifying
- 11 critical strategic goals and initiatives that would mitigate
- 12 homelessness while ensuring that persons experiencing
- 13 homelessness could obtain permanent housing and become
- 14 reintegrated into the community. As one of its statutory
- 15 duties, on September 10, 2012, the council adopted a unified
- 16 statewide ten-year plan. At that time, the point-in-time count,
- 17 or the annual one-day unduplicated count of sheltered and



- 1 unsheltered individuals and families experiencing homelessness,
- 2 totaled 7,921 statewide. Eight years later, in 2020, the point-
- 3 in-time count totaled 6,458.
- 4 While the Hawaii interagency council on homelessness has a
- 5 ten-year plan, the legislature further finds that the State
- 6 lacks a long-term commitment to prevent, reduce, and end
- 7 homelessness. The legislature also finds that various state
- 8 agencies and programs that address homelessness have been built
- 9 up on a piecemeal basis and have approached homelessness in a
- 10 similar manner. There is no central agency tasked with reducing
- 11 and preventing homelessness through the coordination of effort
- 12 between state and local government agencies and private
- 13 entities.
- 14 The legislature recognizes that year-to-year funding,
- 15 rather than consistent funding in the base budget, creates
- 16 uncertainty for the staff of a program. For example, in 2019,
- 17 the legislature enacted Act 81, Session Laws of Hawaii 2019,
- 18 which appointed the governor's coordinator on homelessness to
- 19 administer and enforce the duties and responsibilities of the
- 20 council. The coordinator is currently funded as a special
- 21 project under the department of human services, while the

- 1 coordinator's full-time staff of four are not permanent
- 2 employees. In addition, year-to-year funding among agencies and
- 3 providers for homeless services threatens already potentially
- 4 sporadic and fragmented services, instead of providing
- 5 consistent support that will help permanently house persons
- 6 experiencing homelessness in the State.
- 7 Accordingly, the purpose of this Act is to:
- **8** (1) Establish the office on homelessness and housing
- 9 solutions; and
- 10 (2) Appropriate funds for the administration of the office
- on homelessness and housing solutions, including full-
- time equivalent positions.
- 13 SECTION 2. Chapter 346, Hawaii Revised Statutes, is
- 14 amended by adding a new subpart to part XVIII to be
- 15 appropriately designated and to read as follows:
- 16 " . OFFICE ON HOMELESSNESS AND HOUSING SOLUTIONS
- 17 §346-A Definitions. As used in this subpart, unless the
- 18 context clearly indicates otherwise:
- "Coordinator" means the governor's coordinator on
- 20 homelessness as provided in section 346-381.5.

- 1 "Office" means the office on homelessness and housing 2 solutions. 3 §346-B Office on homelessness and housing solutions; 4 establishment. There is established within the department of 5 human services, for administrative purposes only, the office on 6 homelessness and housing solutions, which shall: 7 (1)Work with state, county, and community agencies to 8 develop solutions to prevent and end homelessness in 9 the State through transitional and permanent housing 10 and supportive or assisted services, or both; and 11 (2) Develop and test innovative solutions to prevent and 12 end homelessness in the State. 13 **\$346-C** Administration. (a) The office on homelessness 14 and housing solutions shall be headed by the governor's 15 coordinator on homelessness, appointed pursuant to section 16 346-381.5, for the proper administration and enforcement of this 17 subpart. 18 The coordinator shall report directly to the governor
- 20 (c) Pursuant to section 346-381.5, the coordinator shall be appointed without regard to chapter 76.

9	annual pr	ogress report to the legislature no later than twenty
10	days prio	r to the convening of each regular session. The report

14	(2)	Performance metrics relating to housing and services

6	§346-F Available vacant public lands inventory. Each			
7	state agency that administers public lands shall provide the			
8	coordinator with an inventory identifying any available vacant			
9	public lands under the jurisdiction of that agency."			
10	SECTION 3. Chapter 346, Hawaii Revised Statutes, is			
11	amended by designating sections 346-381.5 and 346-382 as subpar			
12	A and inserting a title before section 346-381.5 to read as			
13	follows:			
14	"A. General Provisions"			
15	SECTION 4. There is appropriated out of the general			
16	revenues of the State of Hawaii the sum of \$ or so			
17	much thereof as may be necessary for fiscal year 2022-2023 for			
18	the administration of the office on homelessness and housing			
19	solutions, including full-time equivalent (FTE)			
20	positions; provided that each county may provide support for			
21	programs within its county.			

- 1 The sum appropriated shall be expended by the department of
- 2 human services for the purposes of this Act.
- 3 SECTION 5. In codifying the new sections added by section
- 4 2 of this Act, the revisor of statutes shall substitute
- 5 appropriate section numbers for the letters used in designating
- 6 the new sections in this Act.
- 7 SECTION 6. This Act shall take effect on July 1, 2050.
