A BILL FOR AN ACT

RELATING TO SPECIAL PURPOSE REVENUE BONDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the issuance of
- 2 special purpose revenue bonds provides investors in private
- 3 capital improvement projects with tax exemptions when those
- 4 projects are in the public interest. However, the term "public
- 5 interest" is ill-defined, leading to situations where these
- 6 valuable tax exemptions, which decrease the State's tax base,
- 7 are given to projects that are primarily or purely in the
- 8 interest of private entities without clear public benefit. The
- 9 legislature further finds that the creation of jobs alone does
- 10 not sufficiently satisfy the public interest requirement of
- 11 special purpose revenue bonds, especially when those jobs may
- 12 not provide a living wage in Hawaii.
- Accordingly, the purpose of this Act is to define the term
- 14 "public interest" with regard to the issuance of special purpose
- 15 revenue bonds to make it clear that the benefit provided to
- 16 society as a whole must extend beyond the mere creation of jobs.



SECTION 2. Section 39A-31, Hawaii Revised Statutes, is 1 amended by adding a new definition to be appropriately inserted 2 3 and to read as follows: 4 ""Public interest" means that which is beneficial to 5 society as a whole, including but not limited to projects that 6 benefit the health, safety, and general welfare of the people of 7 the State or its political subdivisions; provided that these 8 benefits extend beyond the mere creation of jobs." SECTION 3. Section 39A-71, Hawaii Revised Statutes, is 9 10 amended by adding a new definition to be appropriately inserted 11 and to read as follows: 12 ""Public interest" means that which is beneficial to 13 society as a whole, including but not limited to projects that 14 benefit the health, safety, and general welfare of the people of 15 the State or its political subdivisions; provided that these 16 benefits extend beyond the mere creation of jobs." SECTION 4. Section 39A-111, Hawaii Revised Statutes, is 17 18 amended by adding a new definition to be appropriately inserted and to read as follows: 19 ""Public interest" means that which is beneficial to 20

society as a whole, including but not limited to projects that

- 4 SECTION 5. Section 39A-151, Hawaii Revised Statutes, is

- 9 benefit the health, safety, and general welfare of the people of
- 10 the State or its political subdivisions; provided that these
- 11 benefits extend beyond the mere creation of jobs."
- 12 SECTION 6. Section 39A-191, Hawaii Revised Statutes, is
- 13 amended by adding a new definition to be appropriately inserted
- 14 and to read as follows:
- ""Public interest" means that which is beneficial to
- 16 society as a whole, including but not limited to projects that
- 17 benefit the health, safety, and general welfare of the people of
- 18 the State or its political subdivisions; provided that these
- 19 benefits extend beyond the mere creation of jobs."

1 SECTION 7. Section 39A-221, Hawaii Revised Statutes, is 2 amended by adding a new definition to be appropriately inserted 3 and to read as follows: 4 ""Public interest" means that which is beneficial to society as a whole, including but not limited to projects that 5 benefit the health, safety, and general welfare of the people of 6 the State or its political subdivisions; provided that these 7 benefits extend beyond the mere creation of jobs." 8 9 SECTION 8. Section 39A-251, Hawaii Revised Statutes, is 10 amended by adding a new definition to be appropriately inserted and to read as follows: 11 ""Public interest" means that which is beneficial to 12 13 society as a whole, including but not limited to projects that benefit the health, safety, and general welfare of the people of 14 15 the State or its political subdivisions; provided that these 16 benefits extend beyond the mere creation of jobs." SECTION 9. Section 39A-281, Hawaii Revised Statutes, is 17 18 amended by adding a new definition to be appropriately inserted 19 and to read as follows: 20 ""Public interest" means that which is beneficial to society as a whole, including but not limited to projects that 21

- 1 benefit the health, safety, and general welfare of the people of
- the State or its political subdivisions; provided that these
- 3 benefits extend beyond the mere creation of jobs."
- 4 SECTION 10. Section 39A-311, Hawaii Revised Statutes, is
- 5 amended by adding a new definition to be appropriately inserted
- 6 and to read as follows:
- 7 ""Public interest" means that which is beneficial to
- 8 society as a whole, including but not limited to projects that
- 9 benefit the health, safety, and general welfare of the people of
- 10 the State or its political subdivisions; provided that these
- 11 benefits extend beyond the mere creation of jobs."
- 12 SECTION 11. Section 39A-341, Hawaii Revised Statutes, is
- 13 amended by adding a new definition to be appropriately inserted
- 14 and to read as follows:
- ""Public interest" means that which is beneficial to
- 16 society as a whole, including but not limited to projects that
- 17 benefit the health, safety, and general welfare of the people of
- 18 the State or its political subdivisions; provided that these
- 19 benefits extend beyond the mere creation of jobs."
- 20 SECTION 12. New statutory material is underscored.

1 SECTION 13. This Act shall take effect on July 1, 2022.
