### A BILL FOR AN ACT

RELATING TO SERVICE ANIMALS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislaure finds that while existing law
- 2 makes it a civil violation to knowingly misrepresent as a
- 3 service animal any animal that does not meet the requirements of
- 4 a service animal, information about what animals qualify as
- 5 service animals and as emotional support animals is not well-
- 6 known. This can lead to confusion when a person acquires an
- 7 animal that although benefiting the person does not meet the
- 8 criteria for a service animal. A service animal is defined in
- 9 state law to mean any dog that is individually trained to do
- 10 work or perform tasks for the benefit of an individual with a
- 11 disability, including a physical, sensory, psychiatric,
- 12 intellectual, or other mental disability. Service animals enjoy
- 13 specific privileges that other animals do not, specifically that
- 14 the service animal and their human partner must be accommodated
- 15 in public places.
- 16 The legislaure further finds that making persons who obtain
- 17 emotional support animals aware that the animals do not qualify

- 1 as service animals can be accomplished by requiring the persons
- 2 and businesses that sell or provide the animals for use as
- 3 emotional support animals to provide written notice stating that
- 4 the animals do not have the training required to qualify as
- 5 service animals, are not entitled to the rights and privileges
- 6 accorded by law to service animals, and that knowingly
- 7 misrepresenting the animals as service animals is unlawful. It
- 8 is crucial that this disclaimer also be provided when persons
- 9 purchase certificates, identifications, tags, vests, leashes,
- 10 and harnesses for emotional support animals.
- 11 The purpose of this measure is to require that a disclaimer
- 12 be provided by sellers or providers of emotional support animals
- 13 or certificates, identifications, tags, vests, leashes, and
- 14 harnesses for emotional support animals that the animal is not a
- 15 service animal.
- 16 SECTION 2. Chapter 347, Hawaii Revised Statutes, is
- 17 amended by adding a new section to be appropriately designated
- 18 and to read as follows:
- 19 "§347- Emotional support animals; disclaimer that animal
- 20 is not a service animal; civil penalty. (a) A person or
- 21 business that sells or provides an animal for use as an

11	(b)	A person or business that sells or provides a
12	certifica	te, identification, tag, vest, leash, or harness for an
13	emotional	support animal shall provide written notice to the
14	buyer or	recipient that states the following:
15	(1)	The item does not entitle an emotional support animal
16		to the rights and privileges accorded by law to a
17		service animal; and
18	(2)	Knowingly misrepresenting as a service animal any
19		animal that does not meet the requirements of a
20		service animal, as defined in section 347-2.5, is a
21		violation of section 347-2.6.

1	(c) The written notices described in subsections (a) and		
2	(b) shall be made in at least 12-point bold type and shall be		
3	provided on the receipt for the emotional support animal or the		
4	product described in subsection (b), or on a separate piece of		
5	paper that is attached to the receipt.		
6	(d) Upon a finding of a preponderance of the evidence, a		
7	person who violates subsection (a) or (b) shall be fined not		
8	less than \$100 and not more than \$250 for the first violation,		
9	and not less than \$500 for a second violation and each violation		
10	thereafter.		
11	(e) Nothing in this section shall preclude any other civil		
12	remedies available to a person, entity, or other organization		
13	arising from misrepresentation by another person of a service		
14	animal."		
15	SECTION 3. New statutory material is underscored.

### Report Title:

Deaf and Blind Task Force; Emotional Support Animal; Disclaimer; Service Animal; Penalties

### Description:

Requires that a disclaimer be provided by sellers or providers of emotional support animals or certificates, identifications, tags, vests, leashes, and harnesses for emotional support animals that the animal is not a service animal. Establishes penalties.
