A BILL FOR AN ACT

RELATING TO A SEX TRAFFICKING EMERGENCY SHELTER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that sex trafficking is a
- 2 modern-day form of slavery. According to a September 2018
- 3 report published by Arizona State University and the Hawaii
- 4 state commission on the status of women, it is estimated that
- 5 one out of every eleven men in Hawaii over the age of eighteen
- 6 is an online sex buyer and that there are 74,362 potential sex
- 7 buyers in Hawaii. Moreover, during the coronavirus disease 2019
- 8 pandemic, a service provider for sex trafficking victims in
- 9 Hawaii reported seeing a three hundred per cent increase in
- 10 demand for services, which included trauma-informed care.
- In 2018, as a part of a juvenile justice reform measure,
- 12 the legislature authorized the creation and development of the
- 13 Kawailoa youth and family wellness center at the site of the
- 14 Hawaii youth correctional facilities, including "crisis shelters
- 15 for victims of human and sex trafficking" under section
- 16 352D-7.5(d), Hawaii Revised Statutes. Within a few months of
- 17 that authorization, the Kawailoa campus included an assessment

- 1 center and shelter for young victims of sex trafficking. In
- 2 addition, in the spring of 2021, Ho'ola Nā Pua opened a
- 3 first-of-its-kind, thirty-two bed, residential treatment program
- 4 for victims of sex trafficking in Hawaii.
- 5 The legislature further finds that, despite the development
- 6 of these two much-needed facilities, a gap in service remains
- 7 that can be met by an emergency shelter for minor victims of sex
- 8 trafficking. An emergency shelter for minor victims of sex
- 9 trafficking would improve the State's effectiveness in
- 10 responding to sexual exploitation by allowing government
- 11 agencies and victim service providers to establish a coordinated
- 12 continuum of care and protect victims in a centralized location.
- 13 Accordingly, the purpose of this Act is to authorize the
- 14 department of human services to establish or contract with a
- 15 victim service provider to operate an emergency shelter for
- 16 minors who are victims of sex trafficking and sexual
- 17 exploitation.
- 18 SECTION 2. Chapter 237, Hawaii Revised Statutes, is
- 19 amended by adding a new section to be appropriately designated
- 20 and to read as follows:

- 1 "§237-Exemption for victim service providers of sex trafficking emergency shelters for minors. There shall be 2 exempted from the measure of all taxes imposed by this chapter 3 4 any compensation received by a victim service provider for 5 operating or managing a sex trafficking emergency shelter for 6 minors pursuant to section 346- ." 7 SECTION 3. Chapter 346, Hawaii Revised Statutes, is 8 amended by adding a new section to part I to be appropriately
- 10 "§346- Sex trafficking emergency shelter for minors.
- 11 (a) The department may establish or contract with a victim
- 12 service provider to operate an emergency shelter for sex
- 13 trafficking victims, as a community-based shelter and
- 14 residential facility offered by the office of youth services
- 15 pursuant to section 352D-4(3).

designated and to read as follows:

- 16 (b) The emergency shelter shall provide emergency services
- 17 to sex trafficking victims granted admittance to the shelter.
- 18 Emergency services shall include but not be limited to housing,
- 19 rehabilitation, medical, mental health, therapeutic, diagnostic,
- 20 and legal services.

1	(c) The operator of the emergency shelter, in consult	ation	
2	with any appropriate governmental agency or nongovernmental	<u>-</u>	
3	organization, shall be responsible for determining:		
4	(1) If a sex trafficking victim is eligible for servi	.ces	
5	at the shelter, including the level of need and o	ourse	
6	of treatment for each victim; and		
7	(2) Whether a sex trafficking victim is no longer eli	.gible	
8	for services at the shelter; provided that services	es	
9	for any victim shall not exceed thirty days.		
10	(d) Any person who enters or remains on the premises	of an	
11	emergency shelter authorized by this section after being as	ked	
12	to leave by the department or its designee, a victim service		
13	provider, or a law enforcement officer shall be guilty of a		
14	misdemeanor.		
15	(e) Any compensation received by a victim service provide		
16	for operating or managing an emergency shelter pursuant to	this	
17	section shall be exempt from taxation under chapter 237.		
18	(f) The mayor of any county in the State, by executive	<u>re</u>	
19	order, may exempt the operator of an emergency shelter		
20	established pursuant to this section from real property taxes,		
21	water and cower development feet rates collected for water	^	

- 1 supplied to consumers and for use of sewers, and any other
- 2 county taxes, charges, rates, or fees arising from the operation
- 3 of the sex trafficking emergency shelter; provided that any
- 4 county may enact ordinances to regulate the exemptions
- 5 authorized by this section.
- 6 (q) The department shall require any victim service
- 7 provider with whom it enters into a contract under this section
- 8 to submit to the department a report for each year that the
- 9 contract is in effect. The report shall include a financial
- 10 report and recommendations for improving services for sex
- 11 trafficking victims. Failure to provide the required report
- 12 shall be grounds for the department to terminate a contract with
- 13 the victim service provider.
- 14 (h) Nothing in this section shall prohibit the department
- 15 from establishing additional programs or services for sex
- 16 trafficking victims.
- 17 (i) As used in this section:
- 18 "Minor" means a person who is less than eighteen years of
- 19 age.
- "Sex trafficking victim" means:

1	(1)	A minor subject to an act or practice of prostitution	
2		as described in section 712-1200;	
3	(2)	A minor subject to an act or practice of sex	
4		trafficking, as described in section 712-1202(1)(b);	
5	(3)	A minor who is a victim of the offense of promoting	
6		prostitution under section 712-1203;	
7	(4)	A minor solicited for commercial sexual exploitation,	
8		as described in section 712-1209.1;	
9	(5)	A victim of a severe form of trafficking in persons,	
10		as defined in title 22 United States Code section	
11		7102, who is a minor;	
12	(6)	A victim of sex trafficking, as defined in title 22	
13		United States Code section 7102, who is a minor; or	
14	(7)	A minor subject to the crime of sex trafficking of	
15		children or by force, fraud, or coercion under title	
16		18 United States Code section 1591.	
17	"Victim service provider" means a nonprofit or		
18	nongovernmental organization that provides services to sex		
19	trafficking victims, including outreach, direct intervention,		
20	housing, rehabilitation, education, vocational, medical, mental		
21	health, or substance abuse treatment programs."		

- 1 SECTION 4. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$ or so
- 3 much thereof as may be necessary for fiscal year 2022-2023 for
- 4 the department of human services to establish or contract with a
- 5 victim service provider to operate or manage a sex trafficking
- 6 emergency shelter for minors.
- 7 The sum appropriated shall be expended by the department of
- 8 human services for the purposes of this Act.
- 9 SECTION 5. New statutory material is underscored.
- 10 SECTION 6. This Act shall take effect upon its approval;
- 11 provided that section 4 shall take effect on July 1, 2022.
