A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF THE ATTORNEY GENERAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that in rural areas, such
- 2 as Molokai, a remote island with a population of about seven
- 3 thousand people, many state departments do not have full time
- 4 employees dedicated to enforcement activities available.
- 5 Therefore, when a complaint is made, the state departments do
- 6 not have staff physically present to address the situation;
- 7 instead, many times a state department has to rely on still
- 8 photos and videos that may not capture the full extent of the
- 9 situation or be sufficient to support the issuance of a
- 10 citation. State departments must then make a determination
- 11 whether to send a staff member into the field after the fact to
- 12 conduct an investigation, which can take weeks to schedule
- 13 depending upon flight schedules or staff availability. The
- 14 delay obviously hampers the ability of any government inspector
- 15 to witness the violation and issue an enforceable citation.
- 16 These limitations lead to delays in stopping environmentally

- 1 hazardous activities, that impact the health and safety of the
- 2 residents of Molokai.
- 3 The legislature further finds that a multi-departmental
- 4 investigative hotline may give residents a way to report
- 5 concerns and violations to someone in a remote location who is
- 6 familiar with the local landmarks and regions, as not all
- 7 locations in rural areas such as Molokai have physical addresses
- 8 or cross-streets to identify exact locations. The assignment of
- 9 a trained investigator to rural areas who can communicate
- 10 directly with state departments and utilize the resources of the
- 11 office of the attorney general may address these situations in a
- 12 timely manner and save state departments the unpredictable costs
- 13 of travel and other related expenses.
- 14 The purpose of the Act is to establish and fund:
- 15 (1) An environmental investigative hotline pilot project
- through the department of the attorney general,
- investigations division, that shall implement and
- 18 manage an investigative hotline for Molokai residents
- 19 to report environmental concerns on Molokai; and
- 20 (2) One full time investigator on the island of Molokai to
- investigate environmental concerns.

- 1 SECTION 2. There is established the environmental
- 2 investigative hotline pilot project. The department of the
- 3 attorney general, investigations division, shall implement and
- 4 manage the pilot project for Molokai residents to report
- 5 environmental violations and concerns on Molokai.
- 6 SECTION 3. The department of the attorney general,
- 7 investigations division, shall submit a report of its findings
- 8 and recommendations relating to the environmental investigative
- 9 hotline pilot project, including any proposed legislation, to
- 10 the legislature no later than twenty days prior to the convening
- 11 of the regular session of 2023.
- 12 SECTION 4. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$ or so
- 14 much thereof as may be necessary for fiscal year 2022-2023 for
- 15 the implementation and management of the environmental
- 16 investigative hotline pilot project.
- 17 The sum appropriated shall be expended by the department of
- 18 the attorney general, investigations division, for the purposes
- 19 of this Act.
- 20 SECTION 5. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$ or so

- 1 much thereof as may be necessary for fiscal year 2022-2023 for
- 2 one full time equivalent (1.0 FTE) investigator position on
- 3 Molokai to investigate potential environmental concerns reported
- 4 through the environmental investigative hotline pilot project.
- 5 The sum appropriated shall be expended by the department of
- 6 the attorney general, investigations division, for the purposes
- 7 of this Act.
- 8 SECTION 6. This Act shall take effect on July 1, 2022.
